## A BILL

To require a report and audit on the transfer of personnel  
and functions from Fort Monmouth, New Jersey.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CONDITIONS ON FUNDING TRANSFER OF PER-**  
4                   **SONNEL AND FUNCTIONS FROM FORT MON-**  
5                   **MOUTH, NEW JERSEY.**

6       (a) CONDITIONS.—The Secretary of Defense or the  
7       Secretary of the Army shall not fund the transfer of per-  
8       sonnel or functions from Fort Monmouth, New Jersey,  
9       pursuant to the recommendations of the Defense Base  
10      Closure and Realignment Commission contained in the re-

1 port transmitted to Congress on September 15, 2005,  
2 under section 2903(e) of the Defense Base Closure and  
3 Realignment Act of 1990 (part A of title **XXIX** of Public  
4 Law 101–510; 10 U.S.C. 2687 note) until at least 30 days  
5 after the date on which the Comptroller General completes  
6 an audit of a report of the Secretary of Defense stating  
7 that the movement of organizations, functions, or activi-  
8 ties from Fort Monmouth to Aberdeen Proving Ground  
9 will be accomplished without disruption of their support  
10 to the global war on terror or other critical contingency  
11 operations and that safeguards exist to ensure that nec-  
12 essary redundant capabilities are put in place to mitigate  
13 potential degradation of such support and to ensure max-  
14 imum retention of critical workforce, as required by the  
15 Commission recommendations.

16 (b) SUBMISSION OF REPORT.—The report and audit  
17 referred to in subsection (a) shall be submitted to—

18 (1) the Committee on Armed Services, the  
19 Committee on Appropriations, the Committee on  
20 Education and Labor, and the Committee on Over-  
21 sight and Government Reform of the House of Rep-  
22 resentatives; and

23 (2) the Committee on Armed Services, the  
24 Committee on Appropriations, the Committee on  
25 Health, Education, Labor, and Pensions, and the

1      Committee on Homeland Security and Governmental  
2      Affairs of the Senate.
