A BILL

- To amend the Elementary and Secondary Education Act of 1965 to establish a Volunteer Teacher Advisory Committee.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Teachers at the Table
- 5 Act".
- 6 SEC. 2. VOLUNTEER TEACHER ADVISORY COMMITTEE.
- 7 The matter preceding part A of title I of the Elemen-
- 8 tary and Secondary Education Act of 1965 (20 U.S.C.

1	6311 et seq.) is amended by adding after section 1004
2	(20 U.S.C. 6304) the following:
3	"SEC. 1005. VOLUNTEER TEACHER ADVISORY COMMITTEE.
4	"(a) Establishment.—The Secretary shall estab-
5	lish an advisory committee, to be known as the Volunteer
6	Teacher Advisory Committee (hereafter in this section re-
7	ferred to as the 'Committee').
8	"(b) Duties and Focus.—The duty of the Com-
9	mittee shall be to monitor the effects of this Act, on the
10	ground and in classrooms, and the focus of the Committee
11	shall solely be on children and families.
12	"(c) Membership.—
13	"(1) IN GENERAL.—The membership of the
14	Committee shall consist of 20 public elementary
15	school or secondary school classroom teachers who—
16	"(A) are past or present Teachers of the
17	Year; and
18	"(B) who have submitted an application to
19	the Secretary to serve on the Committee.
20	"(2) List; appointment.—The Secretary shall
21	compile a list of teachers submitting applications
22	under paragraph (1)(B). The members of the Com-
23	mittee shall be appointed as follows:
24	"(A) The Secretary shall appoint 4 teach-
25	ers from the list

1	"(B) The Majority Leader of the Senate
2	shall appoint 4 teachers from the list.
3	"(C) The Minority Leader of the Senate
4	shall appoint 4 teachers from the list.
5	"(D) The Speaker of the House of Rep-
6	resentatives shall appoint 4 teachers from the
7	list.
8	"(E) The Minority Leader of the House of
9	Representatives shall appoint 4 teachers from
10	the list.
11	"(3) Representation requirement.—The
12	members of the Committee shall represent diverse
13	and multiple geographic, grade level, and specialty
14	areas.
15	"(4) Term.—Each member of the Committee
16	shall serve on the Committee for a 2-year term.
17	"(d) Annual Report.—The Committee shall submit
18	to Congress and the Secretary—
19	"(1) on an annual basis, a report on the moni-
20	toring carried out under subsection (a); and
21	"(2) on a quarterly basis, updates on that mon-
22	itoring.
23	"(e) Authorization of Funds.—Of the amounts
24	appropriated to, and available at the discretion of, the Sec-
25	retary for programmatic and administrative expenditures

- 1 for fiscal years 2008 through 2012, a total of \$500,000
- 2 shall be used to establish and carry out the functions of

3 the Committee established under this section.".
