A BILL

To amend title 38, United States Code, to establish within the Department of Veterans Affairs the position of Assistant Secretary for Acquisition, Logistics, and Construction, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Department of Vet-
5 erans Affairs Reorganization Act of 2007”.

6 **SEC. 2. REFERENCES TO TITLE 38, UNITED STATES CODE.**

7 Except as otherwise expressly provided, whenever in
8 this Act an amendment is expressed in terms of an amend-

1 ment to a section or other provision, the reference shall
 2 be considered to be made to a section or other provision
 3 of title 38, United States Code.

4 **SEC. 3. INCREASE IN NUMBER OF AUTHORIZED ASSISTANT**
 5 **SECRETARIES; REVISION OF FUNCTIONS.**

6 (a) Section 308(a) is amended by striking “seven”
 7 and inserting “eight” in the first sentence.

8 (b) Section 308(b) is amended:

9 (1) In paragraph (6), by striking “Capital” and
 10 inserting “Construction capital”; and

11 (2) In paragraph (10) by striking “Procure-
 12 ment” and inserting “Acquisition”.

13 **SEC. 4. INCREASE IN NUMBER OF AUTHORIZED DEPUTY AS-**
 14 **SISTANT SECRETARIES.**

15 Section 308(d)(1) is amended by striking “19” and
 16 inserting “27” in the first sentence.

17 **SEC. 5. CONFORMING AMENDMENTS TO TITLE 38, UNITED**
 18 **STATES CODE.**

19 Title 38, United States Code, is amended as follows:

20 (1) Section 312A is repealed.

21 (2) “312A. Director of Construction and Facili-
 22 ties Management” is stricken from the table of sec-
 23 tions at the beginning of chapter 3.

1 **SEC. 6. CONFORMING AMENDMENT TO TITLE 5, UNITED**
2 **STATES CODE.**

3 Section 5315 of title 5, United States Code, is
4 amended by striking “Assistant Secretaries, Department
5 of Veterans Affairs (7)” and inserting “Assistant Secre-
6 taries, Department of Veterans Affairs (8)”.
