A BILL

To amend the Elementary and Secondary Education Act of 1965 to establish a partnership between the Department of Education and the National Park Service to provide educational opportunities for students and teachers, and for other purposes.

- 3 SECTION 1. NATIONAL PARK RANGER SCHOOL PARTNER-
- 4 SHIP PROGRAM.
- 5 (a) Program Authorized.—
- 6 (1) IN GENERAL.—Part D of title V of the Ele-
- 7 mentary and Secondary Education Act of 1965 (20

1	U.S.C. 7241 et seq.) is amended by adding at the
2	end the following:
3	"Subpart 22—National Park Ranger School
4	Partnerships
5	"SEC. 5621. PROGRAM AUTHORIZED.
6	"(a) In General.—The Secretary, in cooperation
7	with the Director of the National Park Service, may award
8	grants, on a competitive basis, to local educational agen-
9	cies to enable the local educational agencies to carry out
10	the authorized activities described in subsection (c).
11	"(b) Required Partnership.—A local educational
12	agency that receives a grant under this subpart shall carry
13	out the activities described in subsection (c) through a
14	partnership that includes the National Park Service and
15	may include a not-for-profit partner of the National Park
16	Service.
17	"(c) Authorized Activities.—A local educational
18	agency shall use funds provided under this subpart to
19	carry out, through the partnership, both of the following
20	activities:
21	"(1) Providing, for students in kindergarten
22	through grade 12, educational programs (including
23	programs under which instruction is provided by Na-
24	tional Park Service Rangers) that emphasize science.

3	"(2) Providing, for educators of students in
4	kindergarten through grade 12, professional develop-
5	ment opportunities (such as summer institutes) that
6	emphasize science, the environment, natural re-
7	sources, mathematics, history, and civics.
8	"(d) DURATION AND AMOUNTS.—Each grant under
9	this subpart shall be for a period of 3 years, for an aggre-
10	gate amount of not more than \$25,000.
11	"(e) Eligibility.—To be eligible to receive a grant
12	under this subpart, a local educational agency shall—
13	"(1)(A) be adjacent to a facility of the National
14	Park Service;
15	"(B) be close to a Research and Learning Cen-
16	ter of the National Park Service;
17	"(C) have a partnership with or be capable of
18	partnering with a unit of the National Park System;
19	or
20	"(D) have, or agree to develop, a technology-
21	based distance learning link to the National Park
22	Service;
23	"(2) be identified for improvement under sub-
24	section (c) of section 1116; and
25	"(3) be a high need local educational agency.

1	"(f) Criteria.—Grants under this subpart shall be
2	awarded on a competitive basis using criteria established
3	by the Secretary, in collaboration with the Director of the
4	National Park Service.
5	"(g) Reports by Grantees.—Upon completing the
6	grant period for a grant under this section, the local edu-
7	cational agency receiving the grant shall submit to the
8	Secretary a report that identifies—
9	"(1) the number of students participating in
10	the activities described in subsection $(e)(1)$ that were
11	carried out under the grant;
12	"(2) the achievement attained by those students
13	in mathematics, science, and any other academic
14	areas relevant to the activities carried out under the
15	grant, as measured against benchmarks established
16	by the Secretary, in coordination with the National
17	Park Service;
18	"(3) the number of educators participating in
19	the activities described in subsection (e)(2) that were
20	carried out under the grant; and
21	"(4) the professional development received by
22	those educators in mathematics, science, civics, and
23	any other academic areas relevant to the activities
24	carried out under the grant.

- "(h) REPORT BY SECRETARY.—Not later than 3 1 years after the date of enactment of this section, the Sec-3 retary, in coordination with the Director of the National 4 Park Service, shall submit a report to Congress on the implementation of this subpart. The report shall include recommendations on whether and to what extent the pro-6 7 gram should be continued or expanded.". 8 AUTHORIZATION OF APPROPRIATIONS.— 9 Section 5401 of that Act (20 U.S.C. 7241) is 10 amended— (A) by striking "There are" and inserting 11 12 the following: 13 "(a) IN GENERAL.—There are"; and 14 (B) by adding at the end the following: "(b) NATIONAL PARK RANGER SCHOOL PARTNER-15 SHIPS.—There is authorized to be appropriated to carry 16 17 out subpart 22, such sums as may be necessary for fiscal year 2008 and each of the 5 succeeding fiscal years.". 18 19 (3) CLERICAL AMENDMENT.—The table of con-20 tents in section 2 of that Act (20 U.S.C. 6301 note) 21 is amended by adding after the items relating to 22 subpart 21 of part D of title V the following: "SUBPART 22—NATIONAL PARK RANGER SCHOOL PARTNERSHIPS
