- 4 This Act may be cited as the "Internet Safety Edu-
- 5 cation Act of 2007".

1	SEC. 2. GRANTS FOR INTERNET SAFETY EDUCATION PRO-
2	GRAMS.
3	(a) Establishment.—Subject to the availability of
4	the funds authorized to be appropriated under this section,
5	the Attorney General of the United States shall create and
6	administer a competitive grant program for eligible orga-
7	nizations to carry out Internet safety education programs.
8	(b) Eligible Organization.—For purposes of this
9	section, the Attorney General shall by rule define the term
10	eligible organization. The rulemaking conducted under
11	this subsection shall require that the term eligible organi-
12	zation includes State organizations.
13	(c) Definitions.—In this section—
14	(1) the term "Internet safety" includes issues
15	regarding the use of the Internet in a manner that
16	promotes safe online activity for children, includ-
17	ing—
18	(A) interacting with other individuals on
19	social networking programs, chat rooms, email,
20	bulletin boards, instant messaging, and other
21	means of online communication;
22	(B) teaching parents and teachers about
23	online safety for children; and
24	(C) empowering and encouraging parents

1	(2) the term "Internet safety education pro-
2	grams' means programs that provide—
3	(A) age-appropriate free Internet Safety
4	education services to children; and
5	(B) free Internet Safety programs for par-
6	ents and teachers for the purpose of educating
7	children.
8	(d) AUTHORIZATION OF APPROPRIATIONS.—There is
9	authorized to be appropriated \$10,000,000 for grants
10	under this section for each of fiscal years 2008 through
11	2012.
