**A BILL**

To modify the boundary of the Minute Man National  
Historical Park, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Minute Man National  
5       Historical Park Boundary Revision Act”.

1 **SEC. 2. DEFINITIONS.**

2 In this Act:

3 (1) MAP.—The term “map” means the map en-  
4 titled “Minute Man National Historical Park Pro-  
5 posed Boundary”, numbered 406/81001, and dated  
6 July 2007.

7 (2) PARK.—The term “Park” means the  
8 Minute Man National Historical Park in the State  
9 of Massachusetts.

10 (3) SECRETARY.—The term “Secretary” means  
11 the Secretary of the Interior.

12 **SEC. 3. MINUTE MAN NATIONAL HISTORICAL PARK.**

13 (a) BOUNDARY ADJUSTMENT.—

14 (1) IN GENERAL.—The boundary of the Park is  
15 modified to include the area generally depicted on  
16 the map.

17 (2) AVAILABILITY OF MAP.—The map shall be  
18 on file and available for inspection in the appro-  
19 priate offices of the National Park Service.

20 (b) ACQUISITION OF LAND.—The Secretary may ac-  
21 quire the land or an interest in the land described in sub-  
22 section section (a)(1) by—

23 (1) purchase from willing sellers with donated  
24 or appropriated funds;

25 (2) donation; or

26 (3) exchange.

1       (c) ADMINISTRATION OF LAND.—The Secretary shall  
2 administer the land added to the Park under subsection  
3 (a)(1) in accordance with applicable laws (including regu-  
4 lations).

5 **SEC. 4. AUTHORIZATION OF APPROPRIATIONS.**

6       There are authorized to be appropriated such sums  
7 as are necessary to carry out this Act.
