A BILL

To require the Secretary of the Interior to conduct a theme study to identify sites and resources to commemorate and interpret the Cold War.

- 3 SECTION 1. DEFINITIONS.
- 4 (1) Advisory committee.—The term "Advi-
- 5 sory Committee" means the Cold War Advisory
- 6 Committee established under section 3.

1	(2) Secretary.—The term "Secretary" means
2	the Secretary of the Interior.
3	(3) Theme study.—The term "theme study"
4	means the national historic landmark theme study
5	conducted under section 2(a).
6	SEC. 2. COLD WAR THEME STUDY.
7	(a) IN GENERAL.—The Secretary shall conduct a na-
8	tional historic landmark theme study to identify sites and
9	resources in the United States that are significant to the
10	Cold War.
11	(b) RESOURCES.—In conducting the theme study, the
12	Secretary shall consider—
13	(1) the inventory of sites and resources associ-
14	ated with the Cold War completed by the Secretary
15	of Defense under section 8120(b)(9) of the Depart-
16	ment of Defense Appropriations Act, 1991 (Public
17	Law 101–511; 104 Stat. 1906); and
18	(2) historical studies and research of Cold War
19	sites and resources, including—
20	(A) intercontinental ballistic missiles;
21	(B) flight training centers;
22	(C) manufacturing facilities;
23	(D) communications and command centers
24	(such as Cheyenne Mountain, Colorado);

1	(E) defensive radar networks (such as the
2	Distant Early Warning Line);
3	(F) nuclear weapons test sites (such as the
4	Nevada test site); and
5	(G) strategic and tactical aircraft.
6	(c) Contents.—The theme study shall include—
7	(1) recommendations for commemorating and
8	interpreting sites and resources identified by the
9	theme study, including—
10	(A) sites for which studies for potential in-
11	clusion in the National Park System should be
12	authorized;
13	(B) sites for which new national historic
14	landmarks should be nominated; and
15	(C) other appropriate designations;
16	(2) recommendations for cooperative agree-
17	ments with—
18	(A) State and local governments;
19	(B) local historical organizations; and
20	(C) other appropriate entities; and
21	(3) an estimate of the amount required to carry
22	out the recommendations under paragraphs (1) and
23	(2).
24	(d) Consultation.—In conducting the theme study,
25	the Secretary shall consult with—

3	(3) State historic preservation offices; and
4	(4) other interested organizations and individ-

6	(e) Report.—Not later than 3 years after the date
