## A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to ensure that all trailers or mobile homes purchased by the Federal Emergency Management Agency meet the safety standards established by the Secretary of Housing and Urban Development for housing used in programs of the Department of Housing and Urban Development.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### SECTION 1. TRAILERS AND MOBILE HOMES.

- 2 Title IV of the Robert T. Stafford Disaster Relief and
- 3 Emergency Assistance Act (42 U.S.C. 5170 et seq.) is
- 4 amended—
- 5 (1) by redesignating section 425, as added by
- 6 section 607 of the SAFE Port Act (Public Law
- 7 109–347; 120 Stat. 1941) (relating to essential serv-
- 8 ice providers), as section 427; and
- 9 (2) by adding at the end the following:

### 10 "SEC. 428. TRAILERS AND MOBILE HOMES.

- 11 "(a) IN GENERAL.—The Administrator of the Fed-
- 12 eral Emergency Management Agency shall ensure that
- 13 any trailer or mobile home purchased by the Federal
- 14 Emergency Management Agency meets the safety stand-
- 15 ards established by the Secretary of Housing and Urban
- 16 Development under section 50.3(i) of title 24, Code of
- 17 Federal Regulations (relating to limitations on hazardous
- 18 materials in housing to be used in a program of the De-
- 19 partment of Housing and Urban Development), or any
- 20 successor to that section, including any such standards
- 21 for—
- 22 "(1) formaldehyde;
- 23  $\qquad \qquad \text{``(2) lead; or}$
- 24 "(3) any other hazardous material, contamina-
- 25 tion, toxic chemical or gas, or radioactive substance
- that could affect the health or safety of an occupant.

- 1 "(b) Rule of Construction.—Nothing in this sec-
- 2 tion may be construed to relieve the Administrator of the
- 3 Federal Emergency Management Agency of the duty to
- 4 provide safe and secure shelter to individuals and house-
- 5 holds residing in any area that is affected by a major dis-
