**A BILL**

To amend the Oil Pollution Act of 1990 to double the liability limits for single-hull tankers and tank bargers for 2009, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. INCREASED SINGLE-HULL LIABILITY LIMITS**  
 2 **FOR 2009.**

3 Section 1004(a)(1)(A) of the Oil Pollution Act of  
 4 1990 (33 U.S.C. 2704) is amended to read as follows:

5 “(A) with respect to a single-hull vessel,  
 6 including a single-hull vessel fitted with double  
 7 sides only or a double bottom—

8 “(i) only \$3,000 per gross ton, if the  
 9 incident for which liability is imposed  
 10 under section 1002 occurs before January  
 11 1, 2009; and

12 “(ii) only \$6,000 per gross ton, if the  
 13 incident for which liability is imposed  
 14 under section 1002 occurs after December  
 15 31, 2009, and before January 1, 2010;”.

16 **SECTION 1. INCREASED SINGLE-HULL LIABILITY LIMITS.**

17 *Section 1004(a)(1) of the Oil Pollution Act of 1990 (33*  
 18 *U.S.C. 2704(a)(1)) is amended by striking subparagraph*  
 19 *(A) and inserting the following:*

20 “(A) with respect to a single-hull vessel, in-  
 21 cluding a single-hull vessel fitted with double  
 22 sides only or a double bottom—

23 “(i) \$3,000 per gross ton, if the inci-  
 24 dent for which liability is imposed under  
 25 section 1002 occurs after the date of enact-

1 *ment of this clause and before January 1,*  
2 *2009;*

3 *“(ii) \$6,000 per gross ton, if the inci-*  
4 *dent for which liability is imposed under*  
5 *section 1002 occurs after December 31,*  
6 *2008, and before January 1, 2010; and*

7 *“(iii) the maximum amount allowable,*  
8 *consistent with the substantive due process*  
9 *requirements of the Fifth Amendment to the*  
10 *United States Constitution, if the incident*  
11 *for which liability is imposed under section*  
12 *1002 occurs after December 31, 2009;”.*
