A BILL

To establish the Twenty-First Century Water Commission to study and develop recommendations for a comprehensive water strategy to address future water needs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Twenty-First Century
- 3 Water Commission Act of 2008".
- 4 SEC. 2. FINDINGS.
- 5 Congress finds that—
- 6 (1) the Nation's water resources will be under
- 7 increasing stress and pressure in the coming dec-
- 8 ades;
- 9 (2) a thorough assessment of technological and
- economic advances that can be employed to increase
- 11 water supplies or otherwise meet water needs in
- every region of the country is important and long
- overdue; and
- 14 (3) a comprehensive strategy to increase water
- availability and ensure safe, adequate, reliable, and
- sustainable water supplies is vital to the economic
- and environmental future of the Nation.
- 18 SEC. 3. ESTABLISHMENT.
- 19 There is established a commission to be known as the
- 20 "Twenty-First Century Water Commission" (in this Act
- 21 referred to as the "Commission").
- 22 **SEC. 4. DUTIES.**
- The duties of the Commission shall be to—
- 24 (1) use existing water assessments and conduct
- such additional assessments as may be necessary to
- project future water supply and demand;

1	(2) study current water management programs
2	of Federal, Interstate, State, and local agencies, and
3	private sector entities directed at increasing water
4	supplies and improving the availability, reliability,
5	and quality of freshwater resources; and
6	(3) consult with representatives of such agen-
7	cies and entities to develop recommendations con-
8	sistent with laws, treaties, decrees, and interstate
9	compacts for a comprehensive water strategy
10	which—
11	(A) respects the primary role of States in
12	adjudicating, administering, and regulating
13	water rights and water uses;
14	(B) identifies incentives intended to ensure
15	an adequate and dependable supply of water to
16	meet the needs of the United States for the
17	next 50 years;
18	(C) suggests strategies that avoid in-
19	ereased mandates on State and local govern-
20	ments;
21	(D) eliminates duplication and conflict
22	among Federal governmental programs;
23	(E)(C) considers all available technologies
24	and other methods to optimize water supply re-

1	liability, availability, and quality, while safe-
2	guarding the environment;
3	(F)(D) recommends means of capturing
4	excess water and flood water for conservation
5	and use in the event of a drought;
6	(G)(E) suggests financing options for com-
7	prehensive water management projects and for
8	appropriate public works projects;
9	$\overline{(H)}(F)$ suggests strategies to conserve ex-
10	isting water supplies, including recommenda-
11	tions for repairing aging infrastructure and
12	promoting efficiency and conservation; and
13	$\overline{\text{(I)}}(G)$ includes other objectives related to
14	the effective management of the water supply to
15	ensure reliability, availability, and quality,
16	which the Commission shall consider appro-
17	priate.
18	SEC. 5. MEMBERSHIP.
19	(a) Number and Appointment.—The Commission
20	shall be composed of 9 members who shall be appointed
21	not later than 90 days after the date of enactment of this
22	Act. Member shall be appointed as follows:
23	(1) 5 members appointed by the President;

1	(2) 2 members appointed by the Speaker of the
2	House of Representatives, in consultation with the
3	minority leader of the House of Representatives; and
4	(3) 2 members appointed by the majority leader
5	of the Senate, in consultation with the minority lead-
6	er of the Senate.
7	(b) QUALIFICATIONS.—Members shall be appointed
8	to the Commission from among individuals who—
9	(1) are of recognized standing and distinction
10	in water policy issues; and
11	(2) while serving on the Commission, do not
12	hold any other position as an officer or employee of
13	the United States, except as a retired officer or re-
14	tired civilian employee of the United States.
15	(c) Other Considerations.—In appointing mem-
16	bers of the Commission, every effort shall be made to en-
17	sure that the members represent a broad cross section of
18	regional and geographical perspectives in the United
19	States.
20	(d) Chairperson.—The Chairperson of the Com-
21	mission shall be designated by the President.
22	(e) Terms.—Members of the Commission shall be
23	appointed not later than 90 days after the date of enact-
24	ment of this Act and shall serve for the life of the Commis-

25 sion.

- 1 (f) Vacancies.—A vacancy on the Commission shall
- 2 not affect its operation, and shall be filled in the same
- 3 manner as the original appointment provided under sub-
- 4 section (a).
- 5 (g) Compensation and Travel Expenses.—Mem-
- 6 bers of the Commission shall serve without compensation,
- 7 except members shall receive travel expenses, including per
- 8 diem in lieu of subsistence, in accordance with applicable
- 9 provisions under subchapter I of chapter 57, United
- 10 States Code.

11 SEC. 6. MEETINGS AND QUORUM.

- 12 (a) Meetings.—The Commission shall hold its first
- 13 meeting not later than 60 days after the date on which
- 14 all members have been appointed under section 5, and
- 15 shall hold additional meetings at the call of the Chair-
- 16 person or a majority of its members.
- 17 (b) QUORUM.—A majority of the members of the
- 18 Commission shall constitute a quorum for the transaction
- 19 of business.

20 SEC. 7. DIRECTOR AND STAFF.

- A Director shall be appointed by the Speaker of the
- 22 House of Representatives and the majority leader of the
- 23 Senate, in consultation with the minority leader and chair-
- 24 men of the Resources and Transportation and Infrastruc-
- 25 ture Committees of the House of Representatives, and the

- 1 minority leader and chairmen of the Energy and Natural
- 2 Resources and Environment and Public Works Commit-
- 3 tees of the Senate. The Director and any staff reporting
- 4 to the Director shall be paid a rate of pay not to exceed
- 5 the maximum rate of basic pay for GS-15 of the General
- 6 Schedule.

7 SEC. 8. POWERS AND PROCEEDINGS OF THE COMMISSION.

- 8 (a) Hearings.—The Commission shall hold no fewer
- 9 than 10 hearings during the life of the Commission. Hear-
- 10 ings may be held in conjunction with meetings of the Com-
- 11 mission. The Commission may take such testimony and
- 12 receive such evidence as the Commission considers appro-
- 13 priate to carry out this Act. At least 1 hearing shall be
- 14 held in Washington, DC, for the purpose of taking testi-
- 15 mony of representatives of Federal agencies, national or-
- 16 ganizations, and Members of Congress. Other hearings
- 17 shall be scheduled in distinct geographical regions of the
- 18 United States and should seek to ensure testimony from
- 19 individuals with a diversity of experiences, including those
- 20 who work on water issues at all levels of government and
- 21 in the private sector.
- 22 (b) Information and Support From Federal
- 23 Agencies.—Upon request of the Commission, any Fed-
- 24 eral agency shall—

- 1 (1) provide to the Commission, within 30 days 2 of its request, such information as the Commission 3 considers necessary to carry out the provisions of this Act; and (2) detail to temporary duty with the Commis-6 sion on a reimbursable basis such personnel as the 7 Commission considers necessary to carry out the 8 provisions of this Act, in accordance with section 9 5(b)(5), Appendix, title 5, United States Code. 10 SEC. 9. REPORTS. 11 (a) Interim Reports.—Not later than 6 months 12 after the date of the first meeting of the Commission, and 13 every 6 months thereafter, the Commission shall transmit an interim report containing a detailed summary of its 14 15 progress, including meetings and hearings conducted in the interim period, to— 16 17 (1) the President; 18 (2) the Committee on Resources and the Com-19 mittee on Transportation and Infrastructure of the 20 House of Representatives; and
- 21 (3) the Committee on Energy and Natural Re-
- sources and the Committee on the Environment and
- 23 Public Works of the Senate.
- 24 (b) Final Report.—As soon as practicable, but not
- 25 later than 3 years after the date of the first meeting of

- 1 the Commission, the Commission shall transmit a final re-
- 2 port containing a detailed statement of the findings and
- 3 conclusions of the Commission, and recommendations for
- 4 legislation and other policies to implement such findings
- 5 and conclusions, to—
- 6 (1) the President;
- 7 (2) the Committee on Resources and the Com-
- 8 mittee on Transportation and Infrastructure of the
- 9 House of Representatives; and
- 10 (3) the Committee on Energy and Natural Re-
- sources and the Committee on the Environment and
- 12 Public Works of the Senate.
- 13 SEC. 10. TERMINATION.
- 14 The Commission shall terminate not later than 30
- 15 days after the date on which the Commission transmits
- 16 a final report under section 9(b).
- 17 SEC. 11. AUTHORIZATION OF APPROPRIATIONS.
- There are authorized to be appropriated \$9,000,000
- 19 to carry out this Act.
