A BILL

To authorize major medical facility projects and major medical facility leases for the Department of Veterans Affairs for fiscal year 2009, and for other purposes.

- 3 SECTION 1. AUTHORIZATION OF FISCAL YEAR 2009 MAJOR
- 4 MEDICAL FACILITY PROJECTS.

(2) Construction of an outpatient clinic to meet 6 the increased demand for diagnostic procedures, am-7 bulatory surgery, and specialty care in Lee County, 8 Florida, in an amount not to exceed \$131,800,000. 9 (3) Seismic corrections to Building 1 at the De-10 partment of Veterans Affairs Medical Center in San 11 Juan, Puerto Rico, in an amount not to exceed 12 \$225,900,000. 13 (4) Construction of a facility for a state-of-the-14 art polytrauma healthcare and rehabilitation center 15 in San Antonio, Texas, in an amount not to exceed 16 \$66,000,000. 17 SEC. 2. 18	SEC. 4. AUTHORIZATION OF APPROPRIATIONS.
19	(a) Authorization of Appropriations for
20	MAJOR MEDICAL FACILITY PROJECTS.—There is author-
21	ized to be appropriated to the Secretary of Veterans Af-
22	fairs for fiscal year 2009 for the Construction, Major
23	Projects, account—
24	(1) \$477,700,000 for the projects authorized in
25	section 1; and

1	(2) \$1,394,200,000 for projects whose author-
2	ization is extended by section 2.
3	(b) Authorization of Appropriations for Med-
4	ICAL FACILITY LEASES.—There is authorized to be appro-
5	priated to the Secretary of Veterans Affairs for fiscal year
6	2009 for the Medical Facilities account, \$60,114,000 for
7	the leases authorized in section 3.
8	(c) Limitation.—The projects authorized in sections
9	1 and 2 may only be carried out using—
10	(1) funds appropriated for fiscal year 2009 pur-
11	suant to the authorization of appropriations in sub-
12	section (a) of this section;
13	(2) funds available for Construction, Major
14	Projects, for a fiscal year before fiscal year 2009
15	that remain available for obligation;
16	(3) funds available for Construction, Major
17	Projects, for a fiscal year after fiscal year 2009 that
18	remain available for obligation;
19	(4) funds appropriated for Construction, Major
20	Projects, for fiscal year 2009 for a category of activ-
21	ity not specific to a project;
22	(5) funds appropriated for Construction, Major
23	Projects, for a fiscal year before 2009 for a category
24	of activity not specific to a project; and

1 (6) funds appropriated for Construction, Major 2 Projects, for a fiscal year after 2009 for a category 3 of activity not specific to a project.
