Mr. LAUTENBERG (for himself, Mr. KENNEDY, Mr. KERRY, Mrs. BOXER, and Mr. MENENDEZ) introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To amend title 18, United States Code, to prohibit certain interstate conduct relating to exotic animals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sportsmanship in
5 Hunting Act of 2008”.

6 **SEC. 2. FINDINGS AND PURPOSES.**

7 (a) FINDINGS.—Congress finds the following:

8 (1) The ethic of hunting involves the consider-
9 ation of fair chase, which allows the animal the op-
10 portunity to avoid the hunter.

1 (2) At more than 1,000 commercial canned
2 hunt operations across the country, trophy hunters
3 pay a fee to shoot captive exotic animals, from Afri-
4 can lions to giraffes and blackbuck antelope, in
5 fenced-in enclosures.

6 (3) Clustered in a captive setting at unusually
7 high densities, confined exotic animals attract dis-
8 ease more readily than more widely dispersed native
9 species who roam freely.

10 (4) The transportation of captive exotic animals
11 to commercial canned hunt operations can facilitate
12 the spread of disease across great distances.

13 (5) The regulation of the transport and treat-
14 ment of exotic animals on shooting preserves falls
15 outside the traditional domains of State agriculture
16 departments and State fish and game agencies.

17 (b) PURPOSES.—This Act—

18 (1) is limited in its purpose and will not limit
19 the licensed hunting of any native mammals or any
20 native or exotic birds;

21 (2) does not aim to criticize those hunters who
22 pursue animals that are not enclosed within a fence;
23 and

1 (3) does not attempt to prohibit slaughterhouse
 2 activities, nor does it aim to prohibit the routine eu-
 3 thanasia of domesticated farm animals.

4 **SEC. 3. TRANSPORT OR POSSESSION OF EXOTIC ANIMALS**
 5 **FOR PURPOSES OF KILLING OR INJURING**
 6 **THEM.**

7 (a) IN GENERAL.—Chapter 3 of title 18, United
 8 States Code, is amended by adding at the end the fol-
 9 lowing:

10 **“§ 50. Exotic animals**

11 “(a) PROHIBITION.—

12 “(1) IN GENERAL.—Whoever, in or substan-
 13 tially affecting interstate or foreign commerce, know-
 14 ingly transfers, transports, or possesses a confined
 15 exotic animal, for the purposes of allowing the kill-
 16 ing or injuring of that animal for entertainment or
 17 for the collection of a trophy, shall be fined under
 18 this title, imprisoned not more than 1 year, or both.

19 “(2) EXCEPTION.—This section shall not apply
 20 to the killing or injuring of an exotic animal in a
 21 State or Federal natural area reserve undertaking
 22 habitat restoration.

23 “(b) DEFINITIONS.—In this section—

24 “(1) the term ‘confined exotic animal’ means a
 25 mammal of a species not historically indigenous to

1 the United States, that has been held in captivity,
2 whether or not the defendant knows the length of
3 the captivity, for the shorter of—

4 “(A) the majority of the animal’s life; or

5 “(B) a period of 1 year; and

6 “(2) the term ‘captivity’ does not include any
7 period during which an animal lives as it would in
8 the wild—

9 “(A) surviving primarily by foraging for
10 naturally occurring food;

11 “(B) roaming at will over an open area of
12 not less than 1,000 acres; and

13 “(C) having the opportunity to avoid hunt-
14 ers.

15 “(c) ENFORCEMENT.—

16 “(1) IN GENERAL.—Any person authorized by
17 the Secretary of the Interior, acting through the Di-
18 rector of the United States Fish and Wildlife Serv-
19 ice, may—

20 “(A) without a warrant, arrest any person
21 that violates this section (including regulations
22 promulgated under this section) in the presence
23 or view of the arresting person;

1 “(B) execute any warrant or other process
 2 issued by an officer or court of competent juris-
 3 diction to enforce this section; and

4 “(C) with a search warrant, search for and
 5 seize any animal taken or possessed in violation
 6 of this section.

7 “(2) FORFEITURE.—Any animal seized with or
 8 without a search warrant shall be held by the Sec-
 9 retary or by a United States marshal, and upon con-
 10 viction of the defendant, shall be forfeited to the
 11 United States and disposed of by the Secretary of
 12 the Interior in accordance with law.

13 “(3) ASSISTANCE.—The Director of the United
 14 States Fish and Wildlife Service may use by agree-
 15 ment, with or without reimbursement, the personnel
 16 and services of any other Federal or State agency
 17 for the purpose of enforcing this section.”.

18 (b) TECHNICAL AMENDMENT.—The analysis for
 19 chapter 3 of title 18, United States Code, is amended by
 20 adding at the end the following:

“Sec. 50. Exotic animals.”.
