A BILL

To amend the Palo Alto Battlefield National Historic Site Act of 1991 to expand the boundaries of the historic site, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Palo Alto Battlefield
5 National Historic Site Boundary Expansion Act of 2008”.

1 **SEC. 2. BOUNDARY EXPANSION, PALO ALTO BATTLEFIELD**
 2 **NATIONAL HISTORIC SITE, TEXAS.**

3 Section 3(b) of the Palo Alto Battlefield National
 4 Historic Site Act of 1991 (16 U.S.C. 461 note; Public Law
 5 102-304) is amended—

6 (1) in paragraph (1), by striking “(1) The his-
 7 toric site” and inserting the following:

8 “(1) IN GENERAL.—The historic site”;

9 (2) by redesignating paragraph (2) as para-
 10 graph (3);

11 (3) by inserting after paragraph (1) the fol-
 12 lowing:

13 “(2) ADDITIONAL LAND.—

14 “(A) IN GENERAL.—In addition to the
 15 land described in paragraph (1), the historic
 16 site shall consist of approximately 34 acres of
 17 land, as generally depicted on the map entitled
 18 ‘_____’, numbered _____, and dated
 19 _____.”

20 “(B) AVAILABILITY OF MAP.—The map
 21 described in subparagraph (A) shall be on file
 22 and available for public inspection in the appro-
 23 priate offices of the National Park Service.”;
 24 and

25 (4) in paragraph (3) (as redesignated by para-
 26 graph (2))—

1 (A) by striking “(3) Within” and inserting
2 the following:

3 “~~(3)~~ **LEGAL DESCRIPTION.**—Not later than”;
4 and

5 (B) in the second sentence, by striking
6 “map referred to in paragraph (1)” and insert-
7 ing “maps referred to in paragraphs (1) and
8 (2)”.

9 **SECTION 1. SHORT TITLE.**

10 *This Act may be cited as the “Palo Alto Battlefield*
11 *National Historical Park Boundary Expansion and Redes-*
12 *ignation Act of 2008”.*

13 **SEC. 2. DESIGNATION OF PALO ALTO BATTLEFIELD NA-**
14 **TIONAL HISTORICAL PARK.**

15 (a) *IN GENERAL.*—*The Palo Alto Battlefield National*
16 *Historic Site shall be known and designated as the “Palo*
17 *Alto Battlefield National Historical Park”.*

18 (b) *REFERENCES.*—*Any reference in a law, map, regu-*
19 *lation, document, paper, or other record of the United*
20 *States to the historic site referred to in subsection (a) shall*
21 *be deemed to be a reference to the Palo Alto Battlefield Na-*
22 *tional Historical Park.*

23 (c) *CONFORMING AMENDMENTS.*—*The Palo Alto Bat-*
24 *tlefield National Historic Site Act of 1991 (16 U.S.C. 461*
25 *note; Public Law 102–304) is amended—*

1 (1) by striking “National Historic Site” each
 2 place it appears and inserting “National Historical
 3 Park”;

4 (2) in the heading for section 3, by striking “**NA-**
 5 **TIONAL HISTORIC SITE**” and inserting “**NA-**
 6 **TIONAL HISTORICAL PARK**”; and

7 (3) by striking “historic site” each place it ap-
 8 pears and inserting “historical park”.

9 **SEC. 3. BOUNDARY EXPANSION, PALO ALTO BATTLEFIELD**
 10 **NATIONAL HISTORICAL PARK, TEXAS.**

11 Section 3(b) of the Palo Alto Battlefield National His-
 12 toric Site Act of 1991 (16 U.S.C. 461 note; Public Law 102–
 13 304) (as amended by section 2) is amended—

14 (1) in paragraph (1), by striking “(1) The his-
 15 torical park” and inserting the following:

16 “(1) *IN GENERAL.*—The historical park”;

17 (2) by redesignating paragraph (2) as para-
 18 graph (3);

19 (3) by inserting after paragraph (1) the fol-
 20 lowing:

21 “(2) *ADDITIONAL LAND.*—

22 “(A) *IN GENERAL.*—In addition to the land
 23 described in paragraph (1), the historical park
 24 shall consist of approximately 34 acres of land,
 25 as generally depicted on the map entitled ‘Palo

2 *pansion’, numbered 469/80,012, and dated May*
3 *21, 2008.*

4 “(B) *AVAILABILITY OF MAP.*—*The map de-*
5 *scribed in subparagraph (A) shall be on file and*
6 *available for public inspection in the appro-*
7 *priate offices of the National Park Service.”; and*
8 *(4) in paragraph (3) (as redesignated by para-*
9 *graph (2))—*

10 *(A) by striking “(3) Within” and inserting*
11 *the following:*

12 “(3) *LEGAL DESCRIPTION.*—*Not later than*”; and

13 *(B) in the second sentence, by striking*
14 *“map referred to in paragraph (1)” and insert-*
15 *ing “maps referred to in paragraphs (1) and*
16 *(2)”.*
