A BILL

To amend the Iran, North Korea, and Syria Nonproliferation Act to allow certain extraordinary payments in connection with the International Space Station.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "International Space
- 5 Station Payments Act of 2008".

1	SEC. 2. AUTHORITY TO MAKE CERTAIN EXTRAORDINARY
2	PAYMENTS IN CONNECTION WITH THE
3	INTERNATIONAL SPACE STATION.
4	Section 7(1)(B) of the Iran, North Korea, and Syria
5	Nonproliferation Act (Public Law 106–178; 50 U.S.C.
6	1701 note) is amended—
7	(1) by striking "except that such term does not
8	mean payments" and inserting the following: "except
9	that such term does not mean—
10	"(i) payments";
11	(2) by striking "or contract related thereto."
12	and inserting "or contract related thereto; or"; and
13	(3) by adding at the end the following new
14	clause:
15	"(ii) payments in cash or in kind
16	made or to be made by the United States
17	Government between January 1, 2012, and
18	reentry into Earth's atmosphere of the
19	International Space Station at its end of
20	life, for work to be performed or services
21	to be rendered during that period nec-
22	essary to meet United States obligations
23	under the Agreement Concerning Coopera-
24	tion on the Civil International Space Sta-
25	tion, with annex, signed at Washington
26	January 29, 1998, and entered into force

1	March 27, 2001, or any protocol, agree-

4	clause does not allow for payments in cash
5	or in kind to be made by the United States

7	"(I) any cargo services provided
8	by a Progress vehicle; or
9	"(II) any crew transportation or
10	rescue services provided by a Soyuz

12	"(aa) the Orion Crew Explo-
13	ration Vehicle reaches full oper-

15	"(bb) a United States com-
16	mercial provider of crew trans-
17	portation and rescue services
18	demonstrates the capability to
