A BILL

To require the Secretary of Labor to establish a program to provide for workforce training and education, at community colleges, in the fields of renewable energy and efficiency, green technology, and sustainable environmental practices.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Community College
- 5 Sustainability Act".

1 SEC. 2. COMMUNITY COLLEGE SUSTAINABILITY.

- 2 (a) Definition.—In this Act, the term "community
- 3 college" means a 2-year institution of higher education,
- 4 as such term is defined in section 101 of the Higher Edu-
- 5 cation Act of 1965 (20 U.S.C. 1001).
- 6 (b) Workforce Training and Education in Re-
- 7 NEWABLE ENERGY AND EFFICIENCY, GREEN TECH-
- 8 NOLOGY, AND SUSTAINABLE ENVIRONMENTAL PRAC-
- 9 TICES.—From funds made available under subsection (d),
- 10 the Secretary of Labor shall carry out a sustainability
- 11 workforce training and education program. In carrying
- 12 out the program, the Secretary shall award grants to com-
- 13 munity colleges to provide workforce training and edu-
- 14 cation in industries and practices, such as—
- 15 (1) alternative energy, including wind and solar
- 16 energy;
- 17 (2) green construction, green retrofitting, and
- 18 green design;
- 19 (3) green chemistry, green nanotechnology, or
- green technology;
- 21 (4) water and energy conservation;
- 22 (5) recycling and waste reduction;
- 23 (6) sustainable agriculture and farming; and
- 24 (7) sustainable culinary practices.
- 25 (c) AWARD CONSIDERATIONS.—Of the funds made
- 26 available under subsection (b) for a fiscal year, not less

- 1 than \$50,000,000 shall be awarded to community colleges
- 2 with existing (as of the date of the award) sustainability
- 3 programs that lead to certificates or degrees in 1 or more
- 4 of the industries and practices described in paragraphs (1)
- 5 through (7) of subsection (b).
- 6 (d) Authorization of Appropriations.—There
- 7 are authorized to be appropriated and there are appro-
- 8 priated to carry out this Act \$100,000,000 for fiscal year
- 9 2009 and each subsequent fiscal year.
