1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cape Cod National
5 Seashore Advisory Commission Reauthorization Act”.

1 **SEC. 2. REAUTHORIZATION OF THE CAPE COD NATIONAL**
 2 **SEASHORE ADVISORY COMMISSION.**

3 Section 8(a) of Public Law 87–126 (16 U.S.C. 459b–
 4 7(a)) is amended in the second sentence by striking
 5 “2008” and inserting “2018”.

6 **SEC. 2. REAUTHORIZATION OF THE CAPE COD NATIONAL**
 7 **SEASHORE ADVISORY COMMISSION.**

8 *Effective September 26, 2008, section 8(a) of Public*
 9 *Law 87–126 (16 U.S.C. 459b–7(a)) is amended in the sec-*
 10 *ond sentence by striking “2008” and inserting “2018”.*

11 **SEC. 3. NATIONAL PARK SYSTEM ADVISORY BOARD.**

12 *Section 3(f) of the Act of August 21, 1935 (16. U.S.C.*
 13 *463(f)), is amended in the first sentence by striking “2009”*
 14 *and inserting “2010”.*

15 **SEC. 4. CONCESSIONS MANAGEMENT ADVISORY BOARD.**

16 *Section 409(d) of the National Park Service Conces-*
 17 *sions Management Improvement Act of 1998 (16 U.S.C.*
 18 *5958(d)) is amended in the first sentence by striking*
 19 *“2008” and inserting “2009”.*

Amend the title so as to read: “A bill to extend the authority for the Cape Cod National Seashore Advisory Commission and certain other advisory boards.”.
