A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to authorize the President to provide mental health and substance abuse services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Disaster Recovery Sub-
- 5 stance Abuse Mental Health Treatment Act of 2008".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act—

| 22 | dividuals affected by a major disaster (including children |
| 23 | and other vulnerable populations, and emergency response |
| 24 | providers (as that term is defined in section 2 of the |

- 2 or substance abuse problems caused or aggravated by that

- 4 "(b) Financial Assistance.—The assistance pro-
- 5 vided under subsection (a) may include providing financial
- 6 assistance to Federal, State, or local government agencies,
- 7 public or private mental health or substance abuse organi-
- 8 zations, or mental health providers to provide mental
- 9 health or substance abuse services or train individuals to
- 10 provide such services.
- 11 "(c) Duration of Assistance.—
- 12 "(1) IN GENERAL.—The President may provide
- financial assistance under this section relating to a
- particular major disaster to a Federal, State, or
- local government agency or a public or private men-
- tal health or substance abuse organization for a pe-
- riod of not longer than 18 months.
- 18 "(2) Extension.—In limited circumstances,
- such as a catastrophic incident (as that term is de-
- fined in section 501 of the Homeland Security Act
- of 2002 (6 U.S.C. 311), the President may extend
- 22 the period of financial assistance under this section
- 23 if the President determines that the extension is in
- 24 the public interest.".

| 9 | provides mental health or substance abuse services, in co- |
| 10 | ordination with the Administrator of the Federal Emer- |

| 12 | ment officials with responsibilities for providing mental |
| 13 | health or substance abuse prevention and services, shall— |
| 14 | (1) conduct a survey of mental health services |
| 15 | and substance abuse services; and |

| 18 | to individuals affected by major disasters and to |
