To make grants to States to implement statewide portal initiatives, and for other purposes.

Mr. Kerry introduced the following bill; which was read twice and referred to the Committee on Finance

## A BILL

To make grants to States to implement statewide portal initiatives, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Empowering Teaching
- 5 and Learning Through Education Portals Act".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:
- 8 (1) 21st century skills.—The term "21st
- 9 century skills"—

1	(A) means skills that students need to suc-
2	ceed in school, work, and life; and
3	(B) includes—
4	(i) skills related either to core aca-
5	demic subjects or to 21st century themes;
6	(ii) learning and innovation skills,
7	such as—
8	(I) creativity and innovation;
9	(II) critical thinking and problem
10	solving; or
11	(III) communication and collabo-
12	ration; and
13	(iii) life and career skills to prepare
14	students for the global economy, such as—
15	(I) flexibility and adaptability;
16	(II) productivity and account-
17	ability; or
18	(III) leadership and responsi-
19	bility.
20	(2) Core academic subjects; educational
21	AGENCIES; SCHOOLS; STATE.—The terms "core aca-
22	demic subjects", "elementary school", "local edu-
23	cational agency", "secondary school", "State", and
24	"State educational agency" have the meanings given

- the terms in section 9101 of the Elementary and Secondary Education Act of 1965 (20 U.S.C. 7801).
  - (3) COVERED EDUCATOR.—The term "covered educator" means a teacher, administrator, or other professional staff member, at a covered school.
    - (4) COVERED PARENT.—The term "covered parent" means the parent of a covered student.
    - (5) COVERED SCHOOL.—The term "covered school" means a Head Start agency operating a Head Start program, or a public school that is a preschool, elementary school, secondary school, or institution of higher education (including such an institution offering a program leading to a baccalaureate degree or a program leading to an advanced degree).
    - (6) COVERED STUDENT.—The term "covered student" means a student at a covered school.
    - (7) COVERED TEACHER.—The term "covered teacher" means a teacher at a covered school.
    - (8) EDUCATION TECHNOLOGY.—The term "education technology" means any technology resource that improves the learning, training, and engagement of students or helps teachers learn, improve their knowledge, and practice.

1	(9) Institution of Higher Education.—The
2	term "institution of higher education" has the
3	meaning given the term in sections 101 and 102 of
4	the Higher Education Act of 1965 (20 U.S.C. 1001,
5	1002).
6	(10) Professional Development.—The
7	term "professional development" means a resource
8	or training that increases a teacher's skills, content
9	knowledge, or other information that has a positive
10	impact on student learning.
11	(11) Secretary.—The term "Secretary"
12	means the Secretary of Education.
13	SEC. 3. GRANTS.
14	(a) In General.—The Secretary may award grants
15	to eligible States, to pay for the Federal share of the cost
16	of implementing and maintaining education portal initia-
17	tives.
18	(b) Amounts.—The Secretary may award the grants
19	for periods of not less than 1 year and not more than 3
20	years.
21	(c) Federal Share.—
22	(1) IN GENERAL.—The Federal share of the
23	cost described in subsection (a) shall be 50 percent.
24	(2) Non-federal share.—The State may
25	provide the non-Federal share of the cost in cash or

- 5 1 in kind, fairly evaluated, including plant, equipment, 2 or services. The State may provide the non-Federal 3 share from State, local, or private sources. SEC. 4. APPLICATIONS AND AWARDS. 5 (a) In General.—To be eligible to receive a grant under this section for an initiative, a State shall submit an application to the Secretary at such time, in such man-8 ner, and containing such information as the Secretary may 9 require.
- 10 (b) Contents.—The application shall contain, at a 11 minimum—
  - (1) a comprehensive plan for the initiative for which the State seeks the grant, including evidence that the initiative meets the requirements of subsections (a) and (c) of section 5;
    - (2) information describing how the State will provide the non-Federal share of the cost described in section 3(a), and will continue to provide that share during the implementation of the initiative and the remainder of the grant period;
    - (3) information describing how the State will meet the maintenance of effort requirements in section 6;

- 1 (4) information explaining the protocol the 2 State will use to ensure safe and legal access to the 3 education portal;
- 4 (5) an assurance that the State has established 5 or will establish an advisory panel, to provide advice 6 on the implementation and maintenance of the ini-7 tiative, including representatives of leaders in school 8 districts, leaders at institutions of higher education, 9 State educational agencies, parents, and teachers; 10 and
- 11 (6) a plan to ensure sufficient statewide band-12 width capacity and systems access to implement and 13 maintain the State education portal.
- (c) AWARDS.—In determining the amounts of grantsunder this Act, the Secretary—
- (1) shall take into consideration the extent to which a State has developed and implemented an education portal initiative prior to the date of the submission of the application involved; but
- 20 (2) shall not penalize States that have made 21 greater progress in developing and implementing 22 such initiatives.

#### 23 SEC. 5. USE OF FUNDS.

24 (a) REQUIRED USES.—A State that receives a grant 25 under this Act for a fiscal year shall use the funds made

1	available through the grant to implement or maintain an
2	education portal initiative that includes—
3	(1) collecting and making available—
4	(A) high quality resources (including data,
5	tools, and digital media content) for covered
6	educators, covered students, and covered par-
7	ents, that support teaching, leading, and learn-
8	ing, and are, as appropriate, aligned with State
9	education standards; and
10	(B) information for covered teachers to use
11	in assisting covered students to attain skills
12	such as 21st century skills; and
13	(2) collecting resources for ongoing and sustain-
14	able professional development for covered educators,
15	related to the use of education technology, and mak-
16	ing the resources available through the implementa-
17	tion of research-based methods and strategies for
18	teacher coaching, collaborating, or mentoring.
19	(b) Allowable Uses.—The State may use the
20	funds made available through the grant for such an initia-
21	tive, for a portal that—
22	(1) gives covered educators access to formative
23	assessment and other resources to address various
24	student learning styles, needs, and achievement lev-
25	els;

- 1 (2) provides an entry point to other information 2 or services, including information on model examples 3 of effective classroom practices, subscriptions or 4 data systems, content standards, lesson plans, 5 courses of study, engaging interactive media, Web 6 resources, e-mail list management software, online 7 portfolios, after-school program resources, and other 8 educational resources;
  - (3) provides access to technology-based curriculum resources and tools that promote the teaching and learning of 21st century skills;
  - (4) enables covered educators to quickly search for lesson plans, professional development resources, model examples of effective classroom practices, or other resources, by content standard, grade level, or topic;
  - (5) provides an online support network or community for covered educators to collaborate on and discuss teaching, learning, curricula, and experiences, and serves as a communication tool between covered educators and covered parents;
  - (6) includes digital media content developed by a television public broadcasting entity in coordination with the grant recipient; or

- 1 (7) makes available access to 1 or more re-
- 2 source sections of the education portal, subject to
- 3 the protocol described in section 4(b)(4), by covered
- 4 education, covered students, and covered parents,
- 5 from other States (with no requirement for State-
- 6 specific log-ins), so that those covered educators,
- 7 covered students, and covered parents can benefit
- 8 from resources developed in the State, thereby ex-
- 9 panding access to the national learning community.
- 10 (c) Provision of and Access to Resources.—
- 11 The covered educators, covered students, and covered par-
- 12 ents in the State may provide resources and information
- 13 for the education portal, subject to the protocol described
- 14 in section 4(b)(4). The resources and information in the
- 15 education portal shall be accessible statewide by the edu-
- 16 cators, students, and parents, subject to the protocol.
- 17 (d) Other Federal Funds.—A State that receives
- 18 a grant under part A of title II of the Elementary and
- $19\,$  Secondary Education Act of  $1965\,$  (20 U.S.C.  $6601\,$  et
- 20 seq.) may use funds made available through that grant
- 21 to maintain (but not implement) the State's education
- 22 portal initiative under this Act, after the end of the period
- 23 in which the State receives funding under this Act.
- 24 (e) Conforming Amendment.—Section 2113(a) of
- 25 the Elementary and Secondary Education Act of 1965 (20

- 1 U.S.C. 6613(a)) is amended by striking "A" and inserting
- 2 "Subject to section 5 of the Empowering Teaching and
- 3 Learning Through Education Portals Act, a".

#### 4 SEC. 6. MAINTENANCE OF EFFORT.

- 5 (a) In General.—A State that receives a grant
- 6 under this Act for a fiscal year shall maintain the expendi-
- 7 tures of the State for education portal initiatives at a level
- 8 not less than the level of such expenditures of the State
- 9 for the fiscal year preceding the first fiscal year for which
- 10 the State received such a grant.
- 11 (b) REDUCTION.—If the Secretary determines that a
- 12 State, during a fiscal year, expends less than the sum re-
- 13 quired to comply with subsection (a), the Secretary shall—
- 14 (1) determine the difference between the re-
- 15 quired sum and the expenditure; and
- 16 (2) reduce the State's grant under this Act for
- the following year by the amount of the difference.

#### 18 SEC. 7. EVALUATIONS AND CONFERENCE.

- 19 (a) FEDERAL EVALUATION.—The Secretary shall
- 20 conduct an evaluation of each initiative funded under this
- 21 Act. The Secretary shall submit a report containing the
- 22 results of the evaluation to Congress.
- 23 (b) Federal Conference.—Not less often than
- 24 once every 2 years, the Secretary shall hold a conference
- 25 for advisory panels described in section 4(b)(5), to share

1	information on best practices relating to education portal
2	initiatives.
3	(c) State Evaluations.—Each State that receives
4	a grant under this Act shall conduct an evaluation of the
5	initiative funded under the grant, using funds provided as
6	part of the non-Federal share of the costs described in
7	section 3(a). The State shall prepare and submit to the
8	Secretary a report containing the results of the evaluation.
9	SEC. 8. AUTHORIZATION OF APPROPRIATIONS.
10	There is authorized to be appropriated to carry out
11	this Act \$100,000,000 for each of fiscal years 2009
12	through 2012, and such sums as may be necessary for
13	each of the following 2 fiscal years.

5	meaning of section 3 of such Act).".
6	(b) Effective Date.—The amendments made by
7	this section shall apply to contributions made after the
8	date of the enactment of this Act.
