A BILL

To require all public school employees and those employed in connection with a public school to receive FBI background checks prior to being hired, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Safety for Our School-
- 5 children Act of 2008".

1	SEC. 2. BACKGROUND CHECKS FOR PUBLIC SCHOOL EM-
2	PLOYEES.
3	(a) In General.—Title IV of the Elementary and
4	Secondary Education Act of 1965 (20 U.S.C. 7101 et
5	seq.) is amended by adding at the end the following:
6	"PART D—BACKGROUND CHECKS FOR PUBLIC
7	SCHOOL EMPLOYEES
8	"SEC. 4401. DEFINITIONS.
9	"(a) Crime of Violence.—The term 'crime of vio-
10	lence' has the meaning given the term in section 924(c)(3)
11	of title 18, United States Code.
12	"(b) Drunk Driving.—The term 'drunk driving'
13	means driving while intoxicated or driving under the influ-
14	ence of alcohol.
15	"(c) FBI BACKGROUND CHECK.—The term 'FBI
16	background check' means a criminal history background
17	check as described in section 231 of the Crime Control
18	Act of 1990 (42 U.S.C. 13041).
19	"(d) School Employee.—The term 'school em-
20	ployee' means—
21	"(1) an employee of a local educational agency
22	or State educational agency who works either in a
23	public school or has a job duty that results in expo-
24	sure to students, including administrators, teachers,
25	substitute teachers, custodians, cafeteria workers,

and school bus drivers; and

- 2 of a company, that has a contract with a local edu-
- 3 cational agency or State educational agency who

- 6 "(e) Serious Moving Violation.—The term 'seri-
- 7 ous moving violation' means a felonious driving violation,
- 8 as determined by State law.
- 9 "(f) Sexual Predator.—The term 'sexual pred-
- 10 ator' means an individual 18 years of age or older who
- 11 has been convicted of, or pled guilty to, a sexual offense
- 12 against a minor.
- 13 "SEC. 4402. BACKGROUND CHECKS FOR PUBLIC SCHOOL
- 14 EMPLOYEES.
- 15 "(a) In General.—A local educational agency or
- 16 State educational agency that receives Federal funds shall
- 17 obtain an FBI background check on an individual prior
- 18 to making an offer of employment as a school employee
- 19 with such agency to such individual.
- 20 "(b) Prohibition Against Employment of Fel-
- 21 ONS OR VIOLENT CRIMINALS.—A local educational agency
- 22 or State educational agency that receives Federal funds
- 23 may not make an offer of employment to an individual
- 24 for a position as a school employee with such agency if

1	such individual has been convicted of a crime of violence
2	or other felony.
3	"(c) Reporting Sexual Predators.—A local edu-
4	cational agency or State educational agency that receives
5	information from an FBI background check that an indi-
6	vidual who has applied for employment with such agency
7	as a school employee is a sexual predator shall report to
8	local law enforcement that such individual has so applied
9	"(d) Transportation.—A local educational agency
10	or State educational agency that receives Federal funds
11	may not make an offer of employment to an individual
12	for a position as a school bus driver if such individual has
13	been convicted of, or pled guilty to, drunk driving or a
14	serious moving violation.

16	"(3) Prohibition against reallocation.—
17	"(A) In General.—A State educational
18	agency that fails to take an action under this
19	part or takes an action prohibited under this
20	part as described in paragraph (1) or (2) may
21	not reallocate Federal funds provided for teach-
22	er development under title II for planning and
23	administrative use by the agency.
24	"(B) Penalty.—The Secretary shall with-
25	hold all Federal funds under title II to a State

- educational agency if such agency reallocates
 funds as prohibited under subparagraph (A)
 until such agency restores the funds for teacher
 development.
- 5 "(b) Local Educational Agencies.—If a local

- 9 a subgrant or any additional funds under section 2121.".
