A BILL

To require the Administrator of the Environmental Protection Agency to conduct a study on black carbon emissions.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. STUDY BY ADMINISTRATOR OF BLACK CARBON**
2 **EMISSIONS.**

3 (a) STUDY.—The Administrator of the Environ-
4 mental Protection Agency (referred to in this section as
5 the “Administrator”) shall work with representatives of
6 industry and environmental groups as appropriate to con-
7 duct a study of black carbon emissions, including—

8 (1) an identification of—

9 (A) the major sources of black carbon
10 emissions in the United States and throughout
11 the world, an estimate of the quantity of cur-
12 rent and projected future emissions, and the
13 net climate effects of the emissions from those
14 sources;

15 (B) the most recent scientific information
16 and data relevant to the climate-related impacts
17 of black carbon emissions from the sources de-
18 scribed in subparagraph (A);

19 (C) the most effective and cost-effective
20 control technologies, operations, or strategies
21 for additional domestic and international reduc-
22 tions in black carbon reductions, including a
23 lifecycle, cost-effectiveness, and net climate im-
24 pact analysis of control technologies, operations,
25 or strategies that remove or reduce black car-

1 bon, such as installation of diesel particulate fil-
2 ters on existing diesel on- and off-road engines;

3 (D) carbon dioxide equivalency factors or
4 other metrics that compare the warming or
5 other climate effects of black carbon with car-
6 bon dioxide and other greenhouse gases; and

7 (E) the health benefits associated with ad-
8 ditional black carbon reductions; and

9 (2) recommendations of the Administrator re-
10 garding—

11 (A) areas of focus for additional research
12 for technologies, operations, and strategies with
13 the highest potential to reduce black carbon
14 emissions;

15 (B) actions that the Federal Government
16 could take to encourage or require additional
17 black carbon emission reductions; and

18 (C) the development of a climate-beneficial
19 tropospheric ozone reduction strategy, and a de-
20 scription of the relationship of that strategy to
21 the ozone reduction strategy in effect as of the
22 date of enactment of this Act.

23 (b) REPORT.—Not later than 180 days after the date
24 of enactment of this Act, the Administrator shall submit
25 to Congress a report describing the results of the study.

1 (c) AUTHORIZATION OF APPROPRIATIONS.—There
2 are authorized to be appropriated such sums as are nec-
3 essary to carry out this section.
