12	(2) FEDERAL LAND.—The Federal land re-
13	ferred to in subsection (a)(2) is—
14	(A) the approximately 935 acres of Forest
15	Service land identified on the Map as "To Car-
16	son City for Natural Areas'';
17	(B) the approximately 3,604 acres of Bu-
18	reau of Land Management land identified or
19	the Map as "Silver Saddle Ranch and Carson
20	River Area'';
21	(C) the approximately 1,862 acres of Bu-
22	reau of Land Management land identified or
23	the Map as "To Carson City for Parks and
24	Public Purposes'': and

(D) the approximately 75 acres of City 1 2 land in which the Bureau of Land Management 3 has a reversionary interest that is identified on 4 the Map as "Reversionary Interest of the United States Released". 6 (c) Conditions.— 7 (1) Consideration.—Before the conveyance of 8 the 62-acre Bernhard parcel to the City, the City 9 shall deposit in the special account established by 10 section 202(b)(1) an amount equal to 25 percent of 11 the difference between— 12 (A) the amount for which the Bernhard 13 parcel was purchased by the City on July 18, 14 2001; and 15 (B) the amount for which the Bernhard 16 parcel was purchased by the Secretary on 17 March 24, 2006. 18 (2) Conservation easement.—As a condition 19 of the conveyance of the land described in subsection 20 (b)(2)(B), the Secretary, in consultation with Carson

11	serve the natural characteristics of the land in
12	perpetuity.
13	(B) Exception.—Notwithstanding sub-
14	paragraph (A), the City may—
15	(i) conduct projects on the land to re-
16	duce fuels;
17	(ii) construct and maintain trails,
18	trailhead facilities, and any infrastructure
19	on the land that is required for municipal
20	water and flood management activities;

22	(iii) maintain or reconstruct any im-
23	provements on the land that are in exist-
24	ence on the date of enactment of this Act.

1	(2) SILVER SADDLE RANCH AND CARSON RIVER
2	AREA.—
3	(A) In general.—Except as provided in
4	subparagraph (B), the land described in sub-
5	section (b)(2)(B) shall—
6	(i) be managed by the City to protect
7	and enhance the Carson River, the flood-
8	plain and surrounding upland, and impor-
9	tant wildlife habitat; and
10	(ii) be used for undeveloped open
11	space, passive recreation, customary agri-
12	cultural practices, and wildlife protection.
13	(B) Exception.—Notwithstanding sub-
14	paragraph (A), the City may—
15	(i) construct and maintain trails and
16	trailhead facilities on the land;
17	(ii) conduct projects on the land to re-
18	duce fuels;
19	(iii) maintain or reconstruct any im-
20	provements on the land that are in exist-
21	ence on the date of enactment of this Act;
22	and
23	(iv) allow the use of motorized vehi-
24	cles on designated roads, trails, and areas
25	in the south end of Prison Hill.

1	(3) Parks and public purposes.—The land
2	described in subsection (b)(2)(C) shall be managed
3	by the City for—
4	(A) undeveloped open space; and
5	(B) recreation or other public purposes
6	consistent with the Act of June 14, 1926 (com-
7	monly known as the "Recreation and Public
8	Purposes Act") (43 U.S.C. 869 et seq.).
9	(4) Reversionary interest.—
10	(A) Release.—The reversionary interest
11	described in subsection (b)(2)(D) shall termi-
12	nate on the date of enactment of this Act.
13	(B) Conveyance by city.—
14	(i) In General.—If the City sells,
15	leases, or otherwise conveys any portion of
16	the land described in subsection (b)(2)(D),
17	the sale, lease, or conveyance of land shall
18	be—
19	(I) through a competitive bidding
20	process; and
21	(II) except as provided in clause
22	(ii), for not less than fair market
23	value.
24	(ii) Conveyance to government
25	OR NONPROFIT.—A sale, lease, or convey-

1	ance of land described in subsection
2	(b)(2)(D) to the Federal Government, a
3	State government, a unit of local govern-
4	ment, or a nonprofit organization shall be
5	for consideration in an amount equal to
6	the price established by the Secretary of
7	the Interior under section 2741 of title 43,
8	Code of Federal Regulation (or successor
9	regulations).
10	(iii) Disposition of Proceeds.—
11	The gross proceeds from the sale, lease, or
12	conveyance of land under clause (i) shall
13	be distributed in accordance with section
14	202(a).
15	(e) Reversion.—If land conveyed under subsection
16	(a) is used in a manner that is inconsistent with the uses
17	described in paragraph (1), (2), (3), or (4) of subsection
18	(d), the land shall, at the discretion of the Secretary, re-
19	vert to the United States.
20	(f) Miscellaneous Provisions.—
21	(1) In general.—On conveyance of the non-
22	Federal land under subsection (a) to the Secretary
23	of Agriculture, the non-Federal land shall—
24	(A) become part of the Humboldt-Toiyabe
25	National Forest; and

1	(B) be administered in accordance with the
2	laws (including the regulations) and rules gen-
3	erally applicable to the National Forest System.
4	(2) Management plan.—The Secretary of Ag-
5	riculture, in consultation with the City and other in-
6	terested parties, may develop and implement a man-
7	agement plan for National Forest System land that
8	ensures the protection and stabilization of the Na-
9	tional Forest System land to minimize the impacts
10	of flooding on the City.
11	(g) Conveyance to Bureau of Land Manage-
12	MENT.—
13	(1) In general.—If the City offers to convey
14	to the United States title to the non-Federal land
15	described in paragraph (2) that is acceptable to the
16	Secretary of the Interior, the land shall, at the dis-
17	cretion of the Secretary, be conveyed to the United
18	States.
19	(2) Description of Land.—The non-Federal
20	land referred to in paragraph (1) is the approxi-
21	mately 136 acres of land administered by the City
22	and identified on the Map as "To Bureau of Land
23	Management".
24	(3) Costs.—Any costs relating to the convey-
25	ance under paragraph (1), including any costs for

1	surveys and other administrative costs, shall be paid
2	by the Secretary of the Interior.
3	SEC. 102. TRANSFER OF ADMINISTRATIVE JURISDICTION
4	FROM THE FOREST SERVICE TO THE BUREAU
5	OF LAND MANAGEMENT.
6	(a) In General.—Administrative jurisdiction over
7	the approximately 50 acres of Forest Service land identi-
8	fied on the Map as "Parcel $\#1$ " is transferred, from the
9	Secretary of Agriculture to the Secretary of the Interior.
10	(b) Costs.—Any costs relating to the transfer under
11	subsection (a), including any costs for surveys and other
12	administrative costs, shall be paid by the Secretary of the
13	Interior.
14	(e) USE OF LAND.—
15	(1) Right-of-way.—Not later than 120 days
16	after the date of enactment of this Act, the Sec-
17	retary of the Interior shall grant to the City a right-
18	of-way for the maintenance of flood management fa-
19	cilities located on the land.
20	(2) DISPOSAL.—The land referred to in sub-
21	section (a) shall be disposed of in accordance with
22	section 201.
23	(3) Disposition of Proceeds.—The gross
24	proceeds from the disposal of land under paragraph

1	(2) shall be distributed in accordance with section
2	202(a).
3	TITLE II—LAND DISPOSAL
4	SEC. 201. DISPOSAL OF CARSON CITY LAND.
5	(a) In General.—Notwithstanding sections 202 and
6	203 of the Federal Land Policy and Management Act of
7	1976 (43 U.S.C. 1712, 1713), the Secretary of the Inte-
8	rior shall, in accordance with that Act, this title, and other
9	applicable law, and subject to valid existing rights, conduct
10	sales of the Federal land described in subsection (b) to
11	qualified bidders.
12	(b) Description of Land.—The Federal land re-
13	ferred to in subsection (a) is—
14	(1) the approximately 108 acres of Bureau of
15	Land Management land identified as "Lands for
16	Disposal" on the Map; and
17	(2) the approximately 50 acres of land identi-
18	fied as "Parcel #1" on the Map.
19	(c) Compliance With Local Planning and Zon-
20	ING LAWS.—Before a sale of Federal land under sub-
21	section (a), the City shall submit to the Secretary a certifi-
22	cation that qualified bidders have agreed to comply with—
23	(1) City zoning ordinances; and
24	(2) any master plan for the area approved by
25	the City.

1	(d) Method of Sale; Consideration.—The sale
2	of Federal land under subsection (a) shall be—
3	(1) consistent with subsections (d) and (f) of
4	section 203 of the Federal Land Policy and Manage-
5	ment Act of 1976 (43 U.S.C. 1713);
6	(2) unless otherwise determined by the Sec-
7	retary, through a competitive bidding process; and
8	(3) for not less than fair market value.
9	(e) Withdrawal.—
10	(1) In general.—Subject to valid existing
11	rights and except as provided in paragraph (2), the
12	Federal land described in subsection (b) is with-
13	drawn from—
14	(A) all forms of entry and appropriation
15	under the public land laws;
16	(B) location, entry, and patent under the
17	mining laws; and
18	(C) operation of the mineral leasing and
19	geothermal leasing laws.
20	(2) Exception.—Paragraph (1)(A) shall not
21	apply to sales made consistent with this section.
22	(f) Deadline for Sale.—
23	(1) In general.—Except as provided in para-
24	graph (2), not later than 1 year after the date of en-
25	actment of this Act. if there is a qualified bidder for

1	the land described in paragraphs (1) and (2) of sub-
2	section (b), the Secretary of the Interior shall offer
3	the land for sale to the qualified bidder.
4	(2) Postponement; exclusion from sale.—
5	(A) Request by Carson City for Post-
6	PONEMENT OR EXCLUSION.—At the request of
7	the City, the Secretary shall postpone or ex-
8	clude from the sale under paragraph (1) all or
9	a portion of the land described in paragraphs
10	(1) and (2) of subsection (b).
11	(B) Indefinite postponement.—Unless
12	specifically requested by the City, a postpone-
13	ment under subparagraph (A) shall not be in-
14	definite.
15	SEC. 202. DISPOSITION OF PROCEEDS.
16	(a) In General.—Of the proceeds from the sale of
17	land under sections 101(d)(4)(B) and 201(a)—
18	(1) 5 percent shall be paid directly to the State
19	for use in the general education program of the
20	State; and
21	(2) the remainder shall be deposited in a special
22	account in the Treasury of the United States, to be
23	known as the "Carson City Special Account", and
24	shall be available without further appropriation to
25	the Secretary until expended to—

1	(A) reimburse costs incurred by the Bu-
2	reau of Land Management for preparing for the
3	sale of the Federal land described in section
4	201(b), including the costs of—
5	(i) surveys and appraisals; and
6	(ii) compliance with—
7	(I) the National Environmental
8	Policy Act of 1969 (42 U.S.C. 4321
9	et seq.); and
10	(II) sections 202 and 203 of the
11	Federal Land Policy and Management
12	Act of 1976 (43 U.S.C. 1712, 1713);
13	(B) reimburse costs incurred by the Bu-
14	reau of Land Management and Forest Service
15	for preparing for, and carrying out, the trans-
16	fers of land to be held in trust by the United
17	States under section 301; and
18	(C) acquire environmentally sensitive land
19	or an interest in environmentally sensitive land
20	in the City.
21	(b) SILVER SADDLE ENDOWMENT ACCOUNT.—
22	(1) Establishment.—There is established in
23	the Treasury of the United States a special account,
24	to be known as the "Silver Saddle Endowment Ac-

- count", consisting of such amounts as are deposited
 under section 101(c)(1).
- 3 (2) AVAILABILITY OF AMOUNTS.—Amounts de-
- 4 posited in the account established by paragraph (1)
- 5 shall be available to the Secretary, without further
- 6 appropriation, for the oversight and enforcement of
- 7 the conservation easement established under section
- 8 101(c)(2).

9 SEC. 203. URBAN INTERFACE.

- 10 (a) In General.—Except as otherwise provided in
- 11 this Act and subject to valid existing rights, the Federal
- 12 land described in subsection (b) is permanently withdrawn
- 13 from—
- 14 (1) all forms of entry and appropriation under
- the public land laws and mining laws;
- 16 (2) location and patent under the mining laws;
- 17 and
- 18 (3) operation of the mineral laws, geothermal
- leasing laws, and mineral material laws.
- 20 (b) Description of Land.—The land referred to in
- 21 subsection (a) consists of approximately 19,747 acres,
- 22 which is identified on the Map as "Urban Interface With-
- 23 drawal".
- 24 (c) Incorporation of Acquired Land and Inter-
- 25 ESTS.—Any land or interest in land within the boundaries

- 1 of the land described in subsection (b) that is acquired
- 2 by the United States after the date of enactment of this
- 3 Act shall be withdrawn in accordance with this section.
- 4 (d) Off-Highway Vehicle Management.—Until
- 5 the date on which the Secretary, in consultation with the
- 6 State, the City, and any other interested persons, com-
- 7 pletes a transportation plan for Federal land in the City,
- 8 the use of motorized and mechanical vehicles on Federal
- 9 land within the City shall be limited to roads and trails
- 10 in existence on the date of enactment of this Act unless
- 11 the use of the vehicles is needed—
- 12 (1) for administrative purposes; or
- 13 (2) to respond to an emergency.

8	SEC. 301. TRANSFER OF LAND TO BE HELD IN TRUST FOR
9	WASHOE TRIBE.
10	(a) In General.—Subject to valid existing rights,
11	all right, title, and interest of the United States in and
12	to the land described in subsection (b)—
13	(1) shall be held in trust by the United States
14	for the benefit and use of the Tribe; and
15	(2) shall be part of the reservation of the Tribe.
16	(b) Description of Land.—The land referred to in
17	subsection (a) consists of approximately 293 acres, which
18	is identified on the Map as "To Washoe Tribe".
19	(c) Survey.—Not later than 180 days after the date
20	of enactment of this Act, the Secretary of Agriculture shall
21	complete a survey of the boundary lines to establish the
22	boundaries of the land taken into trust under subsection
23	(a).
24	(d) USE OF LAND —

1	(1) Gaming.—Land taken into trust under sub-
2	section (a) shall not be eligible, or considered to
3	have been taken into trust, for class II gaming or
4	class III gaming (as those terms are defined in sec-
5	tion 4 of the Indian Gaming Regulatory Act (25
6	U.S.C. 2703)).
7	(2) Trust land for ceremonial use and
8	CONSERVATION.—With respect to the use of the land
9	taken into trust under subsection (a) that is above
10	the 5,200' elevation contour, the Tribe—
11	(A) shall limit the use of the land to—
12	(i) traditional and customary uses
13	and
14	(ii) stewardship conservation for the
15	benefit of the Tribe; and
16	(B) shall not permit any—
17	(i) permanent residential or rec-
18	reational development on the land; or
19	(ii) commercial use of the land, in-
20	cluding commercial development or gam-
21	ing.
22	(3) Trust land for commercial and resi-
23	DENTIAL USE.—With respect to the use of the land
24	taken into trust under subsection (a), the Tribe shall

1	limit the use of the land below the 5,200' elevation
2	to—
3	(A) traditional and customary uses;
4	(B) stewardship conservation for the ben-
5	efit of the Tribe; and
6	(C)(i) residential or recreational develop-
7	ment; or
8	(ii) commercial use.
9	(4) Thinning; Landscape restoration.—
10	With respect to the land taken into trust under sub-
11	section (a), the Secretary of Agriculture, in consulta-
12	tion and coordination with the Tribe, may carry out
13	any thinning and other landscape restoration activi-
14	ties on the land that is beneficial to the Tribe and
15	the Forest Service.
16	SEC. 302. CORRECTION OF SKUNK HARBOR CONVEYANCE.
17	(a) Purpose.—The purpose of this section is to
18	amend Public Law 108–67 (117 Stat. 880) to make a
19	technical correction relating to the land conveyance au-
20	thorized under that Act.
21	(b) Technical Correction.—Section 2 of Public
22	Law 108–67 (117 Stat. 880) is amended—
23	(1) by striking "Subject to" and inserting the
24	following:
25	"(a) In General.—Subject to";

- (2) in subsection (a) (as designated by para-1 2 graph (1)), by striking "the parcel" and all that fol-3 lows through the period at the end and inserting the 4 following: "and to approximately 23 acres of land 5 identified as 'Parcel A' on the map entitled 'Skunk 6 Harbor Conveyance Correction' and dated Sep-7 tember 12, 2008, the western boundary of which is 8 the low water line of Lake Tahoe at elevation 9 6,223.0 (Lake Tahoe Datum)."; and
- 10 (3) by adding at the end the following:
 - "(b) Survey and Legal Description.—
- "(1) IN GENERAL.—Not later than 180 days
 after the date of enactment of this subsection, the
 Secretary of Agriculture shall complete a survey and
 legal description of the boundary lines to establish
 the boundaries of the trust land.
- 17 "(2) TECHNICAL CORRECTIONS.—The Sec-18 retary may correct any technical errors in the survey 19 or legal description completed under paragraph (1).
- 20 "(c) Public Access and Use.—Nothing in this Act
- 21 prohibits any approved general public access (through ex-
- 22 isting easements or by boat) to, or use of, land remaining
- 23 within the Lake Tahoe Basin Management Unit after the
- 24 conveyance of the land to the Secretary of the Interior,
- 25 in trust for the Tribe, under subsection (a), including ac-

- 7 (d) Transfer.—The Secretary of the Interior, act-
- 8 ing on behalf of and for the benefit of the Tribe, shall
- 9 transfer to the Secretary of Agriculture administrative ju-
- 10 risdiction over the land identified as "Parcel B" on the
- 11 map entitled "Skunk Harbor Conveyance Correction" and
- 12 dated September 12, 2008.
- 13 SEC. 303. AGREEMENT WITH FOREST SERVICE.
- 14 The Secretary of Agriculture, in consultation with the
- 15 Tribe, shall develop and implement a cooperative agree-
- 16 ment that ensures regular access by members of the Tribe
- 17 and other people in the community of the Tribe across
- 18 National Forest System land from the City to Lake Tahoe

- 20 SEC. 304. ARTIFACT COLLECTION.
- 21 (a) Notice.—At least 180 days before conducting
- 22 any ground disturbing activities on the land identified as

- 24 of the proposed activities to provide the Tribe with ade-

- 1 quate time to inventory and collect any artifacts in the

- 3 (b) AUTHORIZED ACTIVITIES.—On receipt of notice
- 4 under subsection (a), the Tribe may collect and possess
- 5 any artifacts relating to the Tribe in the land identified
- 6 as "Parcel #2" on the Map.
