## A BILL

To prohibit the use of funds to continue deployment of the United States Armed Forces in Iraq beyond six months after the date of the enactment of this Act.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Iraq Redeployment Act  
5 of 2007”.

6 **SEC. 2. PROHIBITION ON USE OF FUNDS TO MAINTAIN**

7                   **ARMED FORCES IN IRAQ.**

8       (a) PROHIBITION.—Notwithstanding the Authoriza-  
9 tion for Use of Military Force Against Iraq Resolution of

1 2002 (Public Law 107-243) and except as provided in  
2 subsection (b), no funds appropriated or otherwise made  
3 available under any provision of law may be obligated or  
4 expended to continue the deployment in Iraq of members  
5 of the United States Armed Forces after 180 days after  
6 the date of the enactment of this Act.

7 (b) EXCEPTIONS.—The prohibition under subsection

8 (a) shall not apply to the use of funds—

9 (1) to conduct targeted counterterrorism oper-  
10 ations in Iraq;

11 (2) to provide security for United States infra-  
12 structure and civilian personnel;

13 (3) to allow a limited number of members of  
14 the Armed Forces to conduct specific training for  
15 Iraqi security services;

16 (4) to protect members of the Armed Forces  
17 who are performing the functions described in para-  
18 graphs (1) through (3); or

19 (5) to provide for the carrying out by any de-  
20 partment or agency of the United States Govern-  
21 ment of political, economic, or general reconstruction  
22 activities in Iraq.

23 (c) REPORT.—

24 (1) IN GENERAL.—Not later than 60 days after  
25 the date of the enactment of this Act, the Secretary

1 of Defense and the Secretary of State shall jointly  
2 submit to Congress a report describing a strategy  
3 for the redeployment of members of the Armed  
4 Forces from Iraq not later than 180 days after such  
5 date of enactment.

6 (2) CONTENT.—The report required under  
7 paragraph (1) shall include—

8 (A) an estimate of the number of members  
9 of the Armed Forces needed to perform the ac-  
10 tivities described in paragraphs (1) through (3)  
11 of subsection (b);

12 (B) a strategy for managing the regional  
13 implications of the redeployment of members of  
14 the Armed Forces from Iraq and a description  
15 of the efforts that have been or will be made to  
16 ensure a coordinated diplomatic, political, and  
17 development strategy to accompany the rede-  
18 ployment;

19 (C) a strategy for ensuring the safety and  
20 security of members of the Armed Forces dur-  
21 ing such redeployment; and

22 (D) a strategy for repairing and strength-  
23 ening the Armed Forces to effectively engage

1       and defeat global terrorist networks that threat-  
2       en the United States.
