A BILL

To make the National Parks and Federal Recreational Lands
Pass available at a discount to certain veterans.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Veterans Eagle Parks
3 Pass Act”.

4 **SEC. 2. VETERANS NATIONAL PARKS AND FEDERAL REC-**
5 **REATIONAL LANDS PASS.**

6 Section 805(b) of division J of the Consolidated Ap-
7 propriations Act, 2005 (16 U.S.C. 6804(b)), is amended
8 by adding at the end the following:

9 “(3) VETERANS DISCOUNT.—

10 “(A) IN GENERAL.—The Secretary shall
11 make the National Parks and Federal Rec-
12 reational Lands Pass available, at a cost of
13 \$10, to any veteran who was separated from
14 military service under conditions other than dis-
15 honorably, if the veteran provides proof of the
16 status by presenting a DD214.

17 “(B) TERM.—A National Parks and Fed-
18 eral Recreational Lands Pass issued under this
19 paragraph shall be valid for 1 year after the
20 date of issuance of the pass.”.

21 **SECTION 1. SHORT TITLE.**

22 *This Act may be cited as the “Public Land Military*
23 *Pass Act”.*

1 **SEC. 2. NATIONAL PARKS AND FEDERAL RECREATIONAL**
 2 **LANDS PASS FOR ELIGIBLE INDIVIDUALS.**

3 *Section 805(b) of division J of the Consolidated Appro-*
 4 *priations Act, 2005 (16 U.S.C. 6804(b)), is amended by*
 5 *adding at the end the following:*

6 “(3) *COST TO ELIGIBLE INDIVIDUALS.*—

7 “(A) *IN GENERAL.*—*The Secretary shall*
 8 *make the National Parks and Federal Rec-*
 9 *reational Lands Pass available, at a cost of \$10*
 10 *(subject to the same rate of increase as the reg-*
 11 *ular cost of the National Parks and Federal Rec-*
 12 *reational Lands Pass), to any individual deter-*
 13 *mined to be eligible under subparagraph (C).*

14 “(B) *TERM.*—*A National Parks and Fed-*
 15 *eral Recreational Lands Pass issued under this*
 16 *paragraph shall be valid for 1 year after the date*
 17 *of issuance of the pass.*

18 “(C) *PROOF OF ELIGIBILITY.*—*The Sec-*
 19 *retary, after consultation with the Secretary of*
 20 *Veterans Affairs and the Secretary of Defense,*
 21 *shall determine the appropriate documentation*
 22 *that a veteran or an active duty or reserve mem-*
 23 *ber of the United States Armed Forces shall pro-*
 24 *vide as proof that the veteran or member is eligi-*
 25 *ble for the discount available under this para-*
 26 *graph.*”.

Amend the title so as to read: “A bill to make the National Parks and Federal Recreational Lands Pass available at a discount to military personnel.”.
