## A BILL

To amend the Florida National Forest Land Management Act of 2003 to authorize the conveyance of an additional tract of National Forest System land under that Act, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CONVEYANCES UNDER FLORIDA NATIONAL**  
4       **FOREST LAND MANAGEMENT ACT OF 2003.**

5       (a) ADDITIONAL CONVEYANCE AUTHORIZED.—Sub-  
6       section (b) of section 3 of the Florida National Forest  
7       Land Management Act of 2003 (Public Law 108–152;  
8       117 Stat. 1919) is amended—

1           (1) by striking “and” at the end of paragraph  
2           (17);

3           (2) by redesignating paragraph (18) as para-  
4           graph (19);

5           (3) by inserting after paragraph (17) the fol-  
6           lowing new paragraph:

7           “(18) tract W-1979, located in Leon County  
8           consisting of approximately 114 acres, within T. 1  
9           S., R. 1 W., sec. 25; and”; and

10          (4) in paragraph (19) (as redesignated by para-  
11          graph (2)), by striking “(17)” and inserting “(18)”.

12          (b) ADDITIONAL USE OF PROCEEDS.—Paragraph (2)  
13          of subsection (i) of such section (117 Stat. 1921) is  
14          amended—

15          (1) by striking “and” at the end of subpara-  
16          graph (A);

17          (2) by striking the period at the end of sub-  
18          paragraph (B) and inserting “; and”; and

19          (3) by adding at the end the following new sub-  
20          paragraph:

21                 “(C) acquisition, construction, or mainte-  
22                 nance of administrative improvements for units  
23                 of the National Forest System in the State.”.

1       (c) LIMITATIONS ON USE OF PROCEEDS.—Sub-  
2 section (i) of such section is further amended by adding  
3 at the end the following new paragraphs:

4           “(3) GEOGRAPHICAL AND USE RESTRICTION  
5       FOR CERTAIN CONVEYANCE.—Notwithstanding para-  
6 graph (2), proceeds from the sale or exchange of the  
7 tract described in subsection (b)(18) shall be used  
8 exclusively for the purchase of inholdings in the  
9 Apalachicola National Forest.

10          “(4) RESTRICTION ON USE OF PROCEEDS FOR  
11 ADMINISTRATIVE IMPROVEMENTS.—Proceeds from  
12 any sale or exchange of land under this Act may be  
13 used for administrative improvements, as authorized  
14 by paragraph (2)(C), only if the land generating the  
15 proceeds was improved with infrastructure.”.
