- 7 (a) Sense of Congress.—It is the sense of the Con-
- 8 gress that—
- 9 (1) the Secretary of Health and Human Serv-
- ices (in this Act referred to as the "Secretary"), act-
- ing through the Director of the National Institutes
- of Health and the Director of the National Heart,
- Lung, and Blood Institute (in this title referred to
- as the "Institute"), should continue aggressive work
- on pulmonary hypertension;

- stitute should continue research to expand the un-
