A BILL

For the relief of Rosa Isela Figueroa Rincon, Miguel Angel Figueroa Rincon, Blanca Azucena Figueroa Rincon, and Nancy Araceli Figueroa Rincon.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. PERMANENT RESIDENT STATUS FOR ROSA
4	ISELA FIGUEROA RINCON, MIGUEL ANGEL
5	FIGUEROA RINCON, BLANCA AZUCENA
6	FIGUEROA RINCON, AND NANCY ARACELI
7	FIGUEROA RINCON.
8	(a) In General.—Notwithstanding subsections (a)
9	and (b) of section 201 of the Immigration and Nationality

10 Act, Rosa Isela Figueroa Rincon, Miguel Angel Figueroa

- 1 Rincon, Blanca Azucena Figueroa Rincon, and Nancy
- 2 Araceli Figueroa Rincon shall each be eligible for issuance
- 3 of an immigrant visa or for adjustment of status to that
- 4 of an alien lawfully admitted for permanent residence
- 5 upon filing an application for issuance of an immigrant
- 6 visa under section 204 of such Act or for adjustment of
- 7 status to lawful permanent resident.
- 8 (b) Adjustment of Status.—If Rosa Isela
- 9 Figueroa Rincon, Miguel Angel Figueroa Rincon, Blanca
- 10 Azucena Figueroa Rincon, or Nancy Araceli Figueroa
- 11 Rincon enters the United States before the filing deadline
- 12 specified in subsection (c), he or she shall be considered
- 13 to have entered and remained lawfully and shall, if other-
- 14 wise eligible, be eligible for adjustment of status under
- 15 section 245 of the Immigration and Nationality Act as of
- 16 the date of the enactment of this Act.
- 17 (c) Waiver of Grounds for Removal or Denial
- 18 OF ADMISSION.—
- 19 (1) In General.—Notwithstanding sections
- 20 212(a) and 237(a) of the Immigration and Nation-
- 21 ality Act, Rosa Isela Figueroa Rincon, Miguel Angel
- 22 Figueroa Rincon, Blanca Azucena Figueroa Rincon,
- and Nancy Araceli Figueroa Rincon may not be re-
- 24 moved from the United States, denied admission to
- 25 the United States, or considered ineligible for lawful

- 1 permanent residence in the United States, by reason
- 2 of any ground for removal or denial of admission
- 3 that is reflected in the records of the Department of
- 4 Homeland Security or the Visa Office of the Depart-
- 5 ment of State, on the date of the enactment of this
- 6 Act.
- 7 (2) Rescission of outstanding order of
- 8 REMOVAL.—The Secretary of Homeland Security
- 9 shall rescind any outstanding order of removal or de-
- portation, or any finding of inadmissibility or de-
- portability, that has been entered against Rosa Isela
- 12 Figueroa Rincon, Miguel Angel Figueroa Rincon,
- 13 Blanca Azucena Figueroa Rincon, or Nancy Araceli
- 14 Figueroa Rincon by reason of any ground described
- in paragraph (1).
- 16 (d) Deadline for Application and Payment of
- 17 Fees.—Subsections (a) and (b) shall apply only if the ap-
- 18 plication for issuance of an immigrant visa or the applica-
- 19 tion for adjustment of status is filed with appropriate fees
- 20 within 2 years after the date of the enactment of this Act.
- 21 (e) Reduction of Immigrant Visa Number.—
- 22 Upon the granting of an immigrant visa or permanent res-
- 23 idence to Rosa Isela Figueroa Rincon, Miguel Angel
- 24 Figueroa Rincon, Blanca Azucena Figueroa Rincon, and
- 25 Nancy Araceli Figueroa Rincon, the Secretary of State

- 1 shall instruct the proper officer to reduce by 4, during the
- 2 current or next following fiscal year, the total number of
- 3 immigrant visas that are made available to natives of the
- 4 country of the aliens' birth under section 203(a) of the
- 5 Immigration and Nationality Act or, if applicable, the
- 6 total number of immigrant visas that are made available
- 7 to natives of the country of the aliens' birth under section
- 8 202(e) of such Act.
- 9 (f) Denial of Preferential Immigration Treat-
- 10 MENT FOR CERTAIN RELATIVES.—The natural parents,
- 11 brothers, and sisters of Rosa Isela Figueroa Rincon,
- 12 Miguel Angel Figueroa Rincon, Blanca Azucena Figueroa
- 13 Rincon, and Nancy Araceli Figueroa Rincon shall not, by
- 14 virtue of such relationship, be accorded any right, privi-
- 15 lege, or status under the Immigration and Nationality Act.
