A BILL

To promote the use of certain materials harvested from public lands in the production of renewable fuel, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Renewable Biomass
- 5 Facilitation Act of 2009".
- 6 SEC. 2. RENEWABLE BIOMASS.
- 7 Section 201 of the Energy Independence and Security
- 8 Act of 2007 (Public Law 110–140; 121 Stat. 1519) is
- 9 amended in the amendment made to section 211(o)(1) of

1	the Clean Air Act (42 U.S.C. 7545) by amending subpara-
2	graph (I) of such section 211(o)(1) to read as follows:
3	"(I) Renewable biomass.—The term 're-
4	newable biomass' means—
5	"(A) materials, precommercial thinnings,
6	or removed exotic species that—
7	"(i) are byproducts of preventive
8	treatments (such as trees, wood, brush,
9	thinnings, chips, and slash) that are re-
10	moved—
11	"(I) to reduce hazardous fuels;
12	"(II) to reduce or contain disease
13	or insect infestation; or
14	"(III) to restore ecosystem
15	health;
16	"(ii) would not otherwise be used for
17	higher-value products; and
18	"(iii) are harvested from National
19	Forest System land or public lands (as de-
20	fined in section 103 of the Federal Land
21	Policy and Management Act of 1976) in
22	accordance with—
23	"(I) Federal and State law;
24	"(II) applicable land manage-
25	ment plans: and

1	"(III) the requirements for old-
2	growth maintenance, restoration, and
3	management direction of paragraphs
4	(2), (3), and (4) of subsection (e) of
5	section 102 of the Healthy Forests
6	Restoration Act of 2003 and the re-
7	quirements for large-tree retention of
8	subsection (f) of that section; or
9	"(B) any organic matter that is available
10	on a renewable or recurring basis from non-
11	Federal land or land belonging to an Indian or
12	Indian tribe that is held in trust by the United
13	States or subject to a restriction against alien-
14	ation imposed by the United States, including—
15	"(i) renewable plant material, includ-
16	ing—
17	"(I) feed grains;
18	"(II) other agricultural commod-
19	ities;
20	"(III) other plants and trees; and
21	"(IV) algae; and
22	"(ii) waste material, including—
23	"(I) crop residue;

1	"(II) other vegetative waste ma-
2	terial (including wood waste and wood
3	residues);
4	"(III) animal waste and byprod-
5	ucts (including fats, oils, greases, and
6	manure);
7	"(IV) construction waste; and
8	"(V) food waste and yard
9	waste.".
