To amend title 38, United States Code, to provide for an increase in the amount of monthly dependency and indemnity compensation payable to surviving spouses by the Secretary of Veterans Affairs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Surviving Spouses'
- 5 Benefit Improvement Act of 2009".

- 13 for months beginning after the date that is 6 months after
- 14 the date of the enactment of this Act.
