"(2) In contracting for the delivery of health care 1 under this section, the Secretary shall contract with at 3 least one teaching hospital in each large urban area. In this paragraph— 4 "(A) the term 'teaching hospital' means a hos-5 6 pital which has a teaching program approved as specified in section 1861(b)(6) of the Social Security 7 Act (42 U.S.C. 1395x(b)(6)); and 8 "(B) the term 'large urban area' has the mean-9 ing given that term in the second sentence of section 10 1886(d)(2)(D) of the Social Security Act (42 U.S.C. 11 1395ww(d)(2)(D).". 12
