A BILL

To direct the Secretary of Veterans Affairs to improve health care for women veterans, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Women Veterans Ac-
- 5 cess to Care Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress makes the following findings:
- 8 (1) As of 2008, 15 percent of members of the
- 9 Armed Forces are women.

1 (2) As of 2008, one of every 10 members of the 2 Armed Forces serving in Iraq is a woman. 3 (3) As of 2006, more than 16,000 single moth-4 ers have served in Iraq and Afghanistan. 5 (4) As of 2008, an estimated one-third of 6 women veterans who have sought counseling at the 7 Department of Veterans Affairs report having been 8 the victim of rape or attempted rape during their 9 service. 10 (5) As of 2008, women are the fastest growing 11 group within the veteran population. 12 (6) As of 2008, 11 percent of Operation Endur-13 ing Freedom and Operation Iraqi Freedom veterans 14 were women. 15 (7) As of 2006, more than 155,000 women have 16 served in Operation Enduring Freedom or Operation 17 Iraqi Freedom. 18 (8) As of 2008, nearly half of all women vet-19 erans who served in Operation Enduring Freedom or 20 Operation Iraqi Freedom have enrolled with Depart-

ment of Veterans Affairs health care.

| 11 | SEC. 4. OUTREACH TO WOMEN VETERANS AND FAMILIES. |
| 12 | (a) In General.—The Secretary of Veterans Affairs |
| 13 | shall carry out an outreach program to provide women vet- |
| 14 | erans and families of such veterans with information con- |
| 15 | cerning the following: |
| 16 | (1) The various resources available to such vet- |
| 17 | erans and families, including mental and behavioral |
| 18 | resources. |
| 19 | (2) The conditions and issues such veterans |
| 20 | may experience, including those described under sec- |
| 21 | tion 3(a). |
| 22 | (3) The challenges that family members of such |
| 23 | veterans, especially spouses and children, may expe- |
| 24 | rience. |

- 1 (b) AUTHORITY TO CONTRACT.—The Secretary may
- 2 enter into a contract with a public or private entity to

3 carry out this section.
