at issue, any ongoing support obligation, and wheth-1 2 er such individual presents a risk of flight. The Sec-3 retary may also take into consideration any other 4 factors the Secretary considers relevant or appropriate in making such a determination. The Sec-5 6 retary may at any time reimpose on such individual the restrictions described in paragraph (2) if the 7 8 Secretary determines that such is appropriate.".
