A BILL

To amend the Public Health Service Act to authorize the Secretary of Health and Human Services to make grants to eligible States for the purpose of reducing the student-to-school nurse ratio in public secondary schools, elementary schools, and kindergarten.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Student-to-School
- 5 Nurse Ratio Improvement Act of 2009".

1 SEC. 2. REDUCING STUDENT-TO-SCHOOL NURSE RATIOS.

- Title VIII of the Public Health Service Act (42
- 3 U.S.C. 296 et seq.) is amended by adding at the end the
- 4 following:

5 "PART J—SCHOOL NURSES

6 "SEC. 861. REDUCING STUDENT-TO-SCHOOL NURSE RATIOS.

- 7 "(a) Demonstration Grants.—The Secretary, act-
- 8 ing through the Director of the Centers for Disease Con-
- 9 trol and Prevention, may make demonstration grants to
- 10 eligible States for the purpose of reducing the student-to-
- 11 school nurse ratio in public secondary schools, elementary
- 12 schools, and kindergarten.
- 13 "(b) Report.—Not later than 24 months after the
- 14 date of the enactment of this section, the Secretary shall
- 15 submit to the Congress a report on the results of the dem-
- 16 onstration grant program carried out under this section,
- 17 including an evaluation of the effectiveness of the program
- 18 in improving the student-to-school nurse ratios described
- 19 in subsection (a) and an evaluation of the impact of any
- 20 resulting enhanced health of students on learning.
- 21 "(c) Definitions.—For purposes of this section:
- 22 "(1) The terms 'elementary school' and 'sec-
- ondary school' have the meanings given to those
- terms in section 9101 of the Elementary and Sec-
- ondary Education Act of 1965.

1	"(2) The term 'eligible State' means a State in
2	which the student-to-school nurse ratio in public sec-
3	ondary schools, elementary schools, and kinder-
4	garten is 1,000 or more students to every school
5	nurse.
6	"(3) The term 'nurse' means a licensed nurse.
7	"(d) Authorization of Appropriations.—To
8	carry out this section, there are authorized to be appro-
9	priated such sums as may be necessary for each of the
