A BILL

To amend part C of the Balanced Budget and Emergency Deficit Control Act of 1985 to extend the discretionary spending limits.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Discretionary Spend-
- 5 ing Control Act of 2009".
- 6 SEC. 2. EXTENSION OF DISCRETIONARY SPENDING LIMITS.
- 7 (a) In General.—Paragraphs (1) through (13) of
- 8 section 251(c) of the Balanced Budget and Emergency

- 1 Deficit Control Act of 1985 are amended to read as fol-
- 2 lows:
- 3 "(1) with respect to fiscal year 2010,
- 4 \$1,110,000,000,000 in new budget authority of
- 5 which not more than \$417,967,000,000 shall be for
- 6 the nondefense category;
- 7 "(2) with respect to fiscal year 2011,
- 8 \$975,000,000,000 in new budget authority of which
- 9 not more than \$354,890,000,000 shall be for the
- 10 nondefense category;
- "(3) with respect to fiscal year 2012,
- \$970,000,000,000 in new budget authority of which
- 13 not more than \$340,860,000,000 shall be for the
- 14 nondefense category;
- 15 "(4) with respect to fiscal year 2013,
- \$965,000,000,000 in new budget authority of which
- 17 not more than \$325,100,000,000 shall be for the
- 18 nondefense category; and
- 19 "(5) with respect to fiscal year 2014,
- \$960,000,000,000 in new budget authority of which
- 21 not more than \$306,170,000,000 shall be for the
- 22 nondefense category.".

- 3 SEC. 3. ENFORCEMENT.
- 4 (a) Discretionary Spending Limit Point of
- 5 Order.—Section 312 of the Congressional Budget Act of
- 6 1974 is amended by adding at the end the following new
- 7 subsection:
- 8 "(g) Discretionary Spending Limit Point of
- 9 Order.—It shall not be in order in the House of Rep-
- 10 resentatives or the Senate to consider any bill, joint resolu-
- 11 tion, amendment, or conference report that—
- 12 "(1) increases the discretionary spending limits
- for any ensuing fiscal year after the budget year; or
- 14 "(2) would cause the discretionary spending
- limits for the budget year to be breached.".
- 16 (b) Point of Order Against Budget Resolu-
- 17 TION THAT BREACHES LIMITS.—It shall not be in order
- 18 in the House of Representatives or the Senate to consider
- 19 any concurrent resolution on the budget that would cause
- 20 the discretionary spending limits for the budget year to
- 21 be breached.
- 22 (c) Advance Appropriation Point of Order.—
- 23 Section 312 of the Congressional Budget Act of 1974 (as
- 24 amended by this section) is further amended by adding
- 25 at the end the following new subsection:

- 1 "(i) Advance Appropriation Point of Order.—
- 2 It shall not be in order in the House of Representatives
- 3 or the Senate to consider any appropriation bill or joint
- 4 resolution, or amendment thereto or conference report
- 5 thereon, that provides advance discretionary new budget
- 6 authority that first becomes available for any fiscal year
- 7 after the budget year at an amount for any program,
- 8 project, or activity above the amount of appropriations for
- 9 fiscal year 2007 for such program, project, or activity.".
- 10 SEC. 4. REPORTS.
- Subsections (c)(2) and (f)(2)(A) of section 254 of the
- 12 Balanced Budget and Emergency Deficit Control Act of
- 13 1985 are amended by striking "2002" and inserting
- 14 "2014".
- 15 SEC. 5. EXPIRATION.
- 16 Section 275(b) of the Balanced Budget and Emer-
- 17 gency Deficit Control Act of 1985 is amended by striking
- 18 "2002" and inserting "2014".
