A BILL

To amend title 10, United States Code, to authorize the Secretary of Defense to make grants to recognized science and technology secondary schools to support research and development projects at such schools in science, mathematics, engineering, and technology to supplement the national security functions of the Department of Defense.

6	(a) Establishment of Grant Program.—Chapter
7	111 of title 10, United States Code, is amended by insert-
8	ing after section 2192a the following new section:
9	"§ 2192b. Science, Technology, Engineering, and
10	Mathematics (STEM) Research and Devel-
11	opment Program
12	"(a) Requirement for Program.—The Secretary
13	of Defense shall carry out a program to provide grants
14	to secondary schools described in subsection (b) to support
15	research and development projects at such schools in
16	science, mathematics, engineering, and technology to sup-
17	plement the national security functions of the Department
18	of Defense, as determined by the Secretary. A grant may
19	be made directly to an eligible secondary school or indi-
20	rectly to a local educational agency for the administration
21	of the school or a nonprofit organization supporting re-
22	search and development projects in science, mathematics,
23	engineering, and technology at the school.
24	"(b) Eligible Schools.—To be eligible for a grant
25	under the program, a secondary school must be recognized
26	as a Science and Technology High School or as a sec-

- 1 ondary school with a science and technology program. The
- 2 requirements for such recognition shall be determined by
- 3 the Secretary of Defense, taking into consideration the fol-
- 4 lowing specific criteria:
- 5 "(1) The secondary school must meet a min-
- 6 imum number of required academic years of science
- 7 curriculum.
- 8 "(2) The secondary school must meet a min-
- 9 imum number of academic years of technology or en-
- gineering curriculum.
- 11 "(3) The secondary school must meet a min-
- imum number of academic years of mathematics
- curriculum.
- 14 "(c) Research and Development Topics.—The
- 15 Secretary of Defense, in consultation for the Secretaries
- 16 of the military departments, shall determine potential re-
- 17 search and development topics for which grants may be
- 18 made under the program. The Secretary of Defense shall
- 19 prepare, from such proposed topics, a priority list of
- 20 projects, which shall be published and made available to
- 21 eligible secondary schools.
- 22 "(d) Selection of Grant Recipients.—The Sec-
- 23 retary of Defense shall solicit grant proposals from eligible
- 24 secondary schools. The Secretary shall evaluate submitted
- 25 proposals and make grants on a competitive basis.

- 1 "(e) Monitoring and Results.—The Secretary of
- 2 Defense shall monitor the progress made by grant recipi-
- 3 ents on projects supported using the grant funds and re-
- 4 quire regular updates and progress reports as considered
- 5 necessary by the Secretary. A grant recipient shall docu-
- 6 ment and submit to the Secretary a final report on the
- 7 results of the project.
- 8 "(f) Report on Program.—Not later than Feb-
- 9 ruary 1, 2011, the Secretary of Defense shall submit to
- 10 the congressional defense committees and the Committee
- 11 on Governmental Affairs of the Senate, and the Com-
- 12 mittee on Government Reform of the House of Represent-
- 13 atives a report containing a plan for expanding and im-
- 14 proving the program.".
- 15 (b) CLERICAL AMENDMENT.—The table of sections
- 16 at the beginning of such chapter is amended by inserting
- 17 after the item relating to section 2192a the following new
- 18 item:

"2192b. Science, Technology, Engineering, and Mathematics (STEM) Research and Development Program.".
