A BILL

To amend title 38, United States Code, to provide for the use of entitlement under Post-9/11 Veterans Educational Assistance Program for the pursuit of apprenticeships and on-job training.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Post-9/11 Veterans"
- 5 Job Training Act of 2009".

1	SEC. 2. USE OF ENTITLEMENT UNDER POST-9/11 VETERANS
2	EDUCATIONAL ASSISTANCE PROGRAM FOR
3	APPRENTICESHIPS AND ON-JOB TRAINING.
4	(a) Entitlement.—
5	(1) In general.—Chapter 33 of title 38,
6	United States Code, is amended by inserting after
7	section 3319 the following new section:
8	"§ 3320. Apprenticeships and on-job training
9	"(a) Monthly Benefit.—Except as provided in
10	subsections (b) and (c) of this section, the amount of the
11	monthly benefit payment to an individual pursuing a full-
12	time program of apprenticeship or other on-job training
13	under this chapter is—
14	"(1) for each of the first six months of the indi-
15	vidual's pursuit of such program, 75 percent of the
16	monthly benefit payment otherwise payable to such
17	individual under this chapter;
18	"(2) for each of the second six months of the
19	individual's pursuit of such program, 55 percent of
20	such monthly benefit payment; and
21	"(3) for each of the months following the first
22	12 months of the individual's pursuit of such pro-
23	gram, 35 percent of such monthly benefit payment.
24	"(b) REDUCTION.—In any month in which an indi-
25	vidual pursuing a program of education consisting of a
26	program of apprenticeship or other on-job training fails

- 1 to complete 120 hours of training, the amount of the
- 2 monthly benefit payment payable under this chapter to the
- 3 individual shall be limited to the same proportion of the
- 4 applicable rate determined under subsection (a) of this
- 5 section as the number of hours worked during such month,
- 6 rounded to the nearest eight hours, bears to 120 hours.
- 7 "(c) Housing Allowance.—An individual receiving
- 8 a monthly benefit pursuant to this section shall recieve
- 9 a monthly housing stipend amount equal to the monthly
- 10 amount of the basic allowance for housing payable under
- 11 section 403 of title 37 for a member with dependents in
- 12 pay grade E-5 residing in the military housing area that
- 13 encompasses all or the majority portion of the ZIP code
- 14 area in which the individual resides.
- 15 "(d) Charge to Entitlement.—For each month
- 16 that an individual is paid a monthly benefit payment
- 17 under this chapter, the individual's entitlement under this
- 18 chapter shall be charged at the rate of—
- 19 "(1) 75 percent of a month in the case of pay-
- 20 ments made in accordance with subsection (a)(1) of
- 21 this section;
- "(2) 55 percent of a month in the case of pay-
- 23 ments made in accordance with subsection (a)(2) of
- 24 this section; and

1	"(3) 35 percent of a month in the case of pay-
2	ments made in accordance with subsection (a)(3) of
3	this section.
4	"(e) Reduced Charge to Entitlement.—For
5	any month in which an individual fails to complete 120
6	hours of training, the entitlement otherwise chargeable
7	under subsection (c) of this section shall be reduced in
8	the same proportion as the monthly benefit payment pay-
9	able is reduced under subsection (b) of this section.".
10	(2) CLERICAL AMENDMENT.—The table of sec-
11	tions at the beginning of such chapter is amended
12	by inserting after the item relating to section 3319
13	the following new item:
	"3320. Apprenticeships and on-job training.".
14	(b) Conforming Amendments.—Such title is fur-
15	ther amended as follows:
16	(1) Subsection (b) of section 3313 of such title
17	is amended to read as follows:
18	"(b) Approved Programs of Education.—A pro-
19	gram of education is an approved program of education
20	for purposes of this chapter if the program of education—
21	"(1) is—
22	"(A) offered by an institution of higher
23	learning (as that term is defined in section
24	3452(f) of this title; and

1	"(B) approved for purposes of chapter 30
2	of this title (including approval by the State ap-
3	proving agency concerned; or
4	"(2) in the case of an individual who is not
5	serving on active duty, includes a program of ap-
6	prenticeship or of other on-job training approved as
7	provided in clause (1) or (2), as appropriate, of sec-
8	tion 3687(a) of this title.".
9	(2) Section 3313(a) of such title by inserting
10	after "subsections (e) and (f)" the following: "or
11	section 3320 of this title".
12	(c) Effective Date.—The amendments made by
13	this Act shall take effect as if included in the enactment
14	of the Post-9/11 Veterans Educational Assistance Act of
15	2008 (title V of Public Law 110–252).
