A BILL

To provide for a demonstration project relating to the impact of health information technology on chronic disease management under the Medicare and Medicaid programs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare and Medicaid
- 5 Access Project through Information Technology (MAP IT)
- 6 Act".

| 14 | (b) Structure of Project.—A demonstration |
| 15 | project established under subsection (a) shall— |
| 16 | (1) create a web-based virtual case management |
| 17 | tool that provides access to best practices for man- |
| 18 | aging chronic disease; and |
| 19 | (2) provide chronic disease patients and care- |
| 20 | givers access to their own medical records and to a |
| 21 | single source of information on chronic disease. |
| 22 | (c) Competition.—Not later than 90 days after the |
| 23 | date of the enactment of this Act, the Secretary shall seek |
| 24 | proposals from States to carry out a demonstration project |
| 25 | established in subsection (a). The Secretary shall select |
| 26 | not less than four proposals from those submitted by the |

- 1 States, and at least one proposal selected shall include a
- 2 regional approach featuring access to an integrated hos-
- 3 pital information system in at least two adjoining States
- 4 that permits the measurement of outcomes.
- 5 (d) EVALUATION.—The Secretary shall provide for
- 6 an evaluation of each demonstration project established
- 7 under subsection (a) and a determination of the amount
- 8 of cost-savings resulting from each project.
- 9 (e) AUTHORIZATION OF APPROPRIATIONS.—There
- 10 are authorized to be appropriated such sums as are nec-
- 11 essary to carry out the demonstration project under this
- 12 section. Funds appropriated under this subsection shall
- 13 remain available until expended without fiscal year limita-
- 14 tion.
