AN ACT

To authorize the Secretary of the Interior to grant marketrelated contract extensions of certain timber contracts between the Secretary of the Interior and timber purchasers, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. QUALIFYING TIMBER CONTRACT OPTIONS.

2	(a) DEFINITIONS.—In this section:
3	(1) QUALIFYING CONTRACT.—The term "quali-
4	fying contract" means a contract that has not been
5	terminated by the Bureau of Land Management for
6	the sale of timber on lands administered by the Bu-
7	reau of Land Management that meets all of the fol-
8	lowing criteria:
9	(A) The contract was awarded during the
10	period beginning on January 1, 2005, and end-
11	ing on December 31, 2008.
12	(B) There is unharvested volume remain-
13	ing for the contract.
14	(C) The contract is not a salvage sale.
15	(D) The Secretary determined there is not
16	an urgent need to harvest under the contract
17	due to deteriorating timber conditions that de-
18	veloped after the award of the contract.
19	(2) Secretary.—The term "Secretary" means
20	the Secretary of the Interior, acting through the Di-
21	rector of Bureau of Land Management.
22	(3) Timber purchaser.—The term "timber
23	purchaser" means the party to the qualifying con-
24	tract for the sale of timber from lands administered
25	by the Bureau of Land Management.

- 1 (b) Market-related Contract Extension Op-
- 2 TION.—Upon a timber purchaser's written request, the
- 3 Secretary may make a one-time modification to the quali-
- 4 fying contract to add 3 years to the contract expiration
- 5 date if the written request—
- 6 (1) is received by the Secretary not later than
- 7 90 days after the date of enactment of this Act; and
- 8 (2) contains a provision releasing the United
- 9 States from all liability, including further consider-
- ation or compensation, resulting from the modifica-
- tion under this subsection of the term of a qualifying
- 12 contract.
- 13 (c) Reporting.—Not later than 6 months after the
- 14 date of the enactment of this Act, the Secretary shall sub-
- 15 mit to Congress a report detailing a plan and timeline to
- 16 promulgate new regulations authorizing the Bureau of
- 17 Land Management to extend and renegotiate timber con-
- 18 tracts due to changes in market conditions.
- 19 (d) REGULATIONS.—Not later than 2 years after the
- 20 date of the enactment of this Act, the Secretary shall pro-
- 21 mulgate new regulations authorizing the Bureau of Land
- 22 Management to extend and renegotiate timber contracts
- 23 due to changes in market conditions.
- 24 (e) No Surrender of Claims.—This section shall
- 25 not have the effect of surrendering any claim by the

- 1 United States against any timber purchaser that arose
- 2 under a timber sale contract, including a qualifying con-
- 3 tract, before the date on which the Secretary adjusts the
- 4 contract term under subsection (b).
