## SECTION 1. REPEAL OF MEDICARE DMEPOS COMPETITIVE 2 ACQUISITION PROGRAM. 3 (a) IN GENERAL.—Section 1847 of the Social Security Act (42 U.S.C. 1395w-3) is repealed. 4 5 (b) Effective Date.— 6 (1) IN GENERAL.—The repeal made by sub-7 section (a) shall take effect on the date of the enact-8 ment of this Act. 9 (2) IMPACT ON CURRENT CONTRACTS.—In the 10 case of any contract awarded under section 1847 of 11 the Social Security Act before the date of the repeal 12 of such section— 13 (A) the contract is terminated; 14 (B) no payment shall be made under title 15 XVIII of such Act on or after the date of the 16 enactment of this Act based on such a contract; 17 and 18 (C) to the extent that any damages may be 19 applicable as a result of the termination of such 20 contracts, such damages shall be payable from 21 the Federal Supplementary Medical Insurance 22 Trust Fund under section 1841 of such Act. 23 Construction.—Nothing in this sub-24 section shall be construed to provide an independent
