A BILL

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Infant Abandonment
- 5 Prevention Act of 2009".

8	(c) Definition.—In this section, the term "infant

12	task force shall submit a report to the Congress detailing
13	its methodology, findings, conclusions, and recommenda-
14	tions.
