A BILL

To amend title 38, United States Code, to provide for entitlement under the Post-9/11 Educational Assistance Program to payment for test preparatory courses, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Test Prep for Heroes
5 Act”.

1 **SEC. 2. POST-9/11 EDUCATIONAL ASSISTANCE FOR TEST**
2 **PREPARATORY COURSES.**

3 (a) IN GENERAL.—Section 3315 of title 38, United
4 States Code, is amended—

5 (1) in subsection (a), by inserting before the pe-
6 riod the following: “and one test preparatory
7 course”;

8 (2) in subsection (b)—

9 (A) by inserting “total” before “amount
10 payable”;

11 (B) by inserting “and test preparatory
12 course” after “licensing or certification test”;
13 and

14 (C) in paragraph (2)—

15 (i) by inserting “aggregate amount
16 equal to the” before “fee”; and

17 (ii) by inserting “plus the fee charged
18 for the test preparatory course” after “the
19 test”; and

20 (3) by adding at the end the following new sub-
21 section:

22 “(d) TEST PREPARATORY COURSE DEFINED.—In
23 this section, the term ‘test preparatory course’ means—

24 “(1) a preparatory course for a test that is re-
25 quired or used for admission to an institution of
26 higher education;

1 “(2) or a preparatory course for a test that is
2 required or used for admission to a graduate
3 school.”.

4 (b) CLERICAL AMENDMENTS.—

5 (1) HEADING.—The heading for section 3315
6 of title 38, United States Code, is amended by in-
7 serting after “**tests**” the following: “**; test pre-**
8 **paratory courses**”.

9 (2) TABLE OF SECTIONS.—The table or sec-
10 tions at the beginning of chapter 33 of such title is
11 amended by striking the item relating to section
12 3315 and inserting the following:

“3315. Licensure and certification tests; test preparatory courses.”.

13 (c) EFFECTIVE DATE.—The amendments made by
14 this Act shall take effect **【** **】**.
