A BILL

To provide for the withholding of United States assistance to a foreign country in an amount equal to 110 percent of the total amount of costs incurred by United States hospitals and other medical facilities for the long-term care of aliens unlawfully present in the United States from that country during the preceding fiscal year, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Preventing All Your
- 3 Bucks from Aiding non-Citizens is Key Act" or "PAY-
- 4 BACK Act".
- 5 SEC. 2. WITHHOLDING OF FOREIGN ASSISTANCE TO CER-
- 6 TAIN FOREIGN COUNTRIES.
- 7 (a) IN GENERAL.—Subject to subsection (c), of the
- 8 funds appropriated under titles III through VI by an Act
- 9 making appropriations for the Department of State, for-
- 10 eign operations, and related programs that are made avail-
- 11 able for assistance for a foreign country for a fiscal year,
- 12 an amount equal to 110 percent of the total amount of
- 13 costs incurred by United States hospitals and other med-
- 14 ical facilities for the long-term care of aliens unlawfully
- 15 present in the United States from that country during the
- 16 preceding fiscal year shall be withheld from obligation for
- 17 assistance for the central government of such country
- 18 until the President submits a certification to Congress
- 19 stating that such costs are fully paid.
- 20 (b) AVAILABILITY OF FUNDS.—Notwithstanding any
- 21 other provision of law, funds withheld from obligation pur-
- 22 suant to subsection (a) may be made available to the head
- 23 of U.S. Customs and Border Protection to be used for the
- 24 protection of the border and prevention of illegal immigra-
- 25 tion.

- 1 (c) Limitation.—Subsection (a) shall not include
- 2 amounts that have been withheld under any other provi-
- 3 sion of law.
- 4 (d) Waiver.—The President may waive the require-
- 5 ments set forth in subsection (a) with respect to a par-
- 6 ticular country if the President determines that it is in
- 7 the national interests of the United States to do so.
- 8 (e) Sense of Congress.—It is the sense of Con-
- 9 gress that with respect to a foreign country for which the
- 10 United States—
- 11 (1) does not provide assistance under the provi-
- sions of law described in subsection (a) for a fiscal
- 13 year, and
- 14 (2) owes amounts as a result of loans, credits,
- or other financial obligations for the fiscal year,
- 16 the President should seek to obtain from that country a
- 17 reduction in such United States debt in an amount equal
- 18 to 110 percent of the total amount of costs incurred by
- 19 United States hospitals and other medical facilities for the
- 20 long-term care of aliens unlawfully present in the United
- 21 States from that country during the preceding fiscal year.
- 22 (f) Rule of Construction.—Nothing in this Act
- 23 shall be construed to change any provision of law in effect
- 24 on the date of the enactment of this Act regarding the

- 1 long-term care of individuals lawfully present in the
- 2 United States.
