A BILL

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Honest and Open Tes-
- 5 timony Act".
- 6 SEC. 2. PROHIBITION OF RETALIATORY PERSONNEL AC-
- 7 TIONS AGAINST MEMBERS OF THE ARMED
- 8 FORCES WHO TESTIFY HONESTLY AND OPEN-
- 9 LY ABOUT THEIR SEXUAL ORIENTATION IN A
- 10 CONGRESSIONAL HEARING OR WHO TESTIFY
- 11 REGARDING THE POLICY CONCERNING HO-
- 12 MOSEXUALITY IN THE ARMED FORCES.
- (a) Protected Communication.—Subsection (a)
- 14 of section 1034 of title 10, United States Code, is amend-
- 15 ed by adding at the end the following new paragraph:
- 16 "(3) Protected communication with a Member of
- 17 Congress covered by paragraph (1) includes testimony by
- 18 a member of the armed forces in a Congressional hearing
- 19 regarding the policies set forth in subsection 654(b) of this
- 20 title, including testimony by the member that discloses or
- 21 affirms that the member is homosexual, bisexual, or
- 22 transgender. Such communication is lawful and may not
- 23 be restricted.".
- 24 (b) Prohibition of Retaliatory Personnel Ac-
- 25 TIONS IN RESPONSE TO PROTECTED COMMUNICATION.—

- 1 Subsection (b) of such title is amended by adding at the
- 2 end the following new paragraph:
- 3 "(3) In the case of a member of the armed forces
- 4 who makes a protected communication described in sub-
- 5 section (a)(3), any application of the policies set forth in
- 6 subsection 654(b) of this title (or threat to apply the poli-
- 7 cies) to the member shall be considered to be an unfavor-
- 8 able personnel action prohibited by paragraph (1).".
