A BILL

To amend title 10, United States Code, to require emergency contraception to be available at all military health care treatment facilities.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Compassionate Care
- 5 for Servicewomen Act".

- 4 Section 1074g(a) of title 10, United States Code, is
- 5 amended by adding at the end the following new para-
- 6 graph:
- 7 "(9)(A) Emergency contraception in drug form shall
- 8 be included on the basic core formulary of the uniform
- 9 formulary, notwithstanding any provision of law or regula-
- 10 tion requiring that only drugs ordered or prescribed by
- 11 a physician (or other authorized provider) may be included
- 12 in the uniform formulary. Emergency contraception in
- 13 other-than-drug form may also be included on the basic
- 14 core formulary, notwithstanding any such provision.
- 15 "(B) Nothing in subparagraph (A) may be construed
- 16 to require emergency contraception to be covered under
- 17 the pharmacy benefits program.
- 18 "(C) Notwithstanding paragraph (4), prior author-
- 19 ization shall not be required for emergency contraception.
- 20 Nothing in the preceding sentence may be construed as
- 21 waiving any provision of the Federal Food, Drug, and Cos-
- 22 metic Act (21 U.S.C. 301 et seq.) or any other provision
- 23 of law administered by the Food and Drug Administra-
- 24 tion, including rules and orders of such Administration in
- 25 effect at any time under such Act or other provisions of
- 26 law.

"(D) In this paragraph, the term 'emergency contraception' means a drug, drug regimen, or device that is—
"(i) approved by the Food and Drug Administration to prevent pregnancy; and
"(ii) used postcoitally.".
