A BILL

To amend title 10, United States Code, to authorize spaceavailable travel on military aircraft for unremarried surviving spouses of retired members of the uniformed services and the unremarried surviving spouses of veterans who died from a service-connected or compensable disability, and for the dependents of such spouses.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

- This Act may be cited as the "Securing Patriots Ac-
- 3 cess to Convenient and Economic Air Travel Act of 2009"
- 4 or "SPACE-A Travel Act of 2009".
- 5 SEC. 2. ELIGIBILITY OF UNREMARRIED SURVIVING
- 6 SPOUSES OF DECEASED RETIRED MEMBERS
- 7 AND CERTAIN OTHER VETERANS FOR SPACE-
- 8 AVAILABLE TRAVEL ON MILITARY AIRCRAFT.
- 9 (a) Eligibility.—Chapter 157 of title 10, United
- 10 States Code, is amended by inserting after section 2641b
- 11 the following new section:
- 12 "§ 2641c. Space-available travel on Department of De-
- 13 fense aircraft: unremarried surviving
- spouses of deceased retired members and
- 15 certain other veterans; dependents
- 16 "(a) Unremarried Surviving Spouses.—(1) The
- 17 unremarried surviving spouse of a retired member of the
- 18 uniformed services shall be provided transportation on De-
- 19 partment of Defense aircraft, on a space-available basis,
- 20 on the same basis as a spouse of a retired member.
- 21 "(2) The unremarried surviving spouse of a former
- 22 member of the uniformed services who is entitled to de-
- 23 pendency and indemnity compensation under section 1311
- 24 of title 38 shall be provided transportation on Department
- 25 of Defense aircraft, on a space-available basis, on the same
- 26 basis as a spouse of a retired member. The Secretary of

- 1 Defense, in consultation with the Secretary of Veterans
- 2 Affairs, shall develop an effective method to identify sur-
- 3 viving spouses eligible for transportation under this para-
- 4 graph.
- 5 "(b) Dependents.—The dependent of a surviving
- 6 spouse described in subsection (a) who is accompanied by
- 7 the surviving spouse shall be provided transportation on
- 8 Department of Defense aircraft, on a space-available
- 9 basis, on the same basis as the surviving spouse.
- 10 "(c) Exception To Sponsor Accompaniment Re-
- 11 QUIREMENT.—The requirement that dependents of a re-
- 12 tired member be accompanied by the sponsoring member
- 13 in order to receive space-available transportation shall not
- 14 apply to transportation provided under this section.".
- 15 (b) Clerical Amendment.—The table of sections
- 16 at the beginning of such chapter is amended by inserting
- 17 after the item relating to section 2641b the following new
- 18 item:

"2641c. Space-available travel on Department of Defense aircraft: unremarried surviving spouses of deceased retired members and certain other veterans; dependents.".
