To amend the Homeland Security Act of 2002 to authorize the Secretary of Homeland Security to establish the Cyber Security Domestic Preparedness Consortium, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Cyber Security Domes-
- 5 tic Preparedness Act".

1	SEC. 2. AUTHORIZATION OF CYBER SECURITY DOMESTIC
2	PREPAREDNESS CONSORTIUM.
3	(a) AUTHORIZATION.—Subtitle C of title II of the
4	Homeland Security Act of 2002 (6 U.S.C. 121 et seq.)
5	is amended by adding at the end the following new section:
6	"SEC. 226. CYBER SECURITY DOMESTIC PREPAREDNESS
7	CONSORTIUM.
8	"(a) In General.—The Secretary may establish a
9	consortium to be known as the 'Cyber Security Domestic
10	Preparedness Consortium'.
11	"(b) Functions.—The Consortium may—
12	"(1) provide training to State and local first re-
13	sponders and officials specifically for preparing and
14	responding to cyber security attacks;
15	"(2) develop and update a curriculum and
16	training model for State and local first responders
17	and officials;
18	"(3) provide technical assistance services to
19	build and sustain capabilities in support of cyber se-
20	curity preparedness and response; and
21	"(4) conduct cyber security training and sim-
22	ulation exercises to defend from and respond to
23	cyber attacks.
24	"(c) Members.—The Consortium shall consist of
25	academic, nonprofit and government partners that de-
