A BILL

To authorize the Administrator of the Small Business Administration to make grants to small business concerns to assist the commercialization of research developed with funds received under the second phase of the Small Business Innovation Research Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Small Business Inno-
- 5 vation to Job Creation Act of 2010".

1	SEC. 2. COMMERCIALIZATION GRANTS TO SMALL BUSI-
2	NESSES RECEIVING SBIR SECOND PHASE
3	FUNDS.
4	(a) Establishment.—The Administrator of the
5	Small Business Administration is authorized to make
6	grants on a competitive basis to small business concerns
7	to assist the commercialization of research developed by
8	such small business concerns with funds received under
9	the second phase of the Small Business Innovation Re-
10	search Program.
11	(b) Eligibility.—The Administrator may only
12	award a grant under this section to a small business con-
13	cern that—
14	(1) received second phase funds during fiscal
15	year 2007 or 2008, or both;
16	(2) continues to meet the criteria for receiving
17	second phase funds at the time the grant is award-
18	ed, except for any such criteria that the Adminis-
19	trator determines are no longer applicable;
20	(3) has obtained from the Federal agency from
21	which the small business concern received second
22	phase funds a recommendation that the small busi-
23	ness concern be made a grant under this section;
24	(4) has not previously received a grant under
25	this section for the commercialization of the same
26	research; and

1	(5) submits an application at such time and in
2	such form as the Administrator may require, includ-
3	ing—
4	(A) a description of the commercialization
5	project for which the small business concern
6	will use the grant funds;
7	(B) the budget for such project; and
8	(C) a certification that the small business
9	concern meets the criteria described in para-
10	graph (2).
11	(c) Grant Amount.—A grant under this section
12	shall be in an amount the Administrator, in consultation
13	with the Federal agency from which the small business
14	concern received second phase funds, considers appro-
15	priate, but such grant shall not exceed the amount of the
16	second phase funds received by such small business con-
17	cern with respect to the research involved.
18	(d) Definitions.—In this section—
19	(1) the term "Administrator" means the Ad-
20	ministrator of the Small Business Administration;
21	and
22	(2) the terms "Federal agency", "research",
23	"second phase", and "Small Business Innovation
24	Research Program" have the meanings given such

- terms in section 9(e) of the Small Business Act (15
- 2 U.S.C. 638(e)).
- 3 (e) AUTHORIZATION OF APPROPRIATIONS.—There
- 4 are authorized to be appropriated to carry out this section
- 5 \$2,000,000,000 for fiscal year 2011.
