A BILL

To amend title 38, United States Code, to direct the Secretary of Veterans Affairs to furnish hospital care, medical services, and nursing home care to veterans who were stationed at Camp Lejeune, North Carolina, while the water was contaminated at Camp Lejeune, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Janey Ensminger
3 Act”.

4 **SEC. 2. HOSPITAL CARE, MEDICAL SERVICES, AND NURS-**
5 **ING HOME CARE FOR VETERANS STATIONED**
6 **AT CAMP LEJEUNE, NORTH CAROLINA,**
7 **WHILE THE WATER WAS CONTAMINATED AT**
8 **CAMP LEJEUNE.**

9 (a) IN GENERAL.—Section 1710(e)(1) of title 38,
10 United States Code, is amended by adding at the end the
11 following new subparagraph:

12 “(F) Subject to paragraph (2), a veteran who, as a
13 member of the Armed Forces, was stationed at Camp
14 Lejeune, North Carolina, during a period, determined by
15 the Secretary in consultation with the Agency for Toxic
16 Substances and Disease Registry, in which the water at
17 Camp Lejeune was contaminated by volatile organic com-
18 pounds, including known human carcinogens and probable
19 human carcinogens, is eligible for hospital care, medical
20 services, and nursing home care under subsection
21 (a)(2)(F) for any illness, notwithstanding that there is in-
22 sufficient medical evidence to conclude that such illness
23 is attributable to such contamination.”.

24 (b) FAMILY MEMBERS.—

1 (1) IN GENERAL.—Subchapter VIII of chapter
2 17 of title 38, United States Code, is amended by
3 adding at the end the following new section:

4 **“§ 1786. Health care of family members of veterans**
5 **stationed at Camp Lejeune, North Caro-**
6 **lina, while the water was contaminated**
7 **at Camp Lejeune**

8 “(a) IN GENERAL.—A family member of a veteran
9 described in subparagraph (F) of section 1710(e)(1) of
10 this title who resided at Camp Lejeune, North Carolina,
11 during the period described in such subparagraph, or who
12 was in utero during such period while the mother of such
13 family member resided at such location, shall be eligible
14 for hospital care, medical services, and nursing home care
15 furnished by the Secretary for any covered condition, or
16 any covered disability that is associated with a condition,
17 that is associated with exposure to the contaminants in
18 the water at Camp Lejeune during such period.

19 “(b) COVERED CONDITIONS AND DISABILITIES.—In
20 this section, covered conditions and disabilities are those
21 conditions and disabilities described in section 1119(a)(2)
22 of this title.”.

23 (2) CLERICAL AMENDMENT.—The table of sec-
24 tions at the beginning of such chapter is amended

1 by inserting after the item relating to section 1785
 2 the following new item:

“1786. Health care of family members of veterans stationed at Camp Lejeune,
 North Carolina, while the water was contaminated at Camp
 Lejeune.”.

3 **SEC. 3. PRESUMPTIONS OF SERVICE CONNECTION FOR ILL-**
 4 **NESSES ASSOCIATED WITH CONTAMINANTS**
 5 **IN THE WATER SUPPLY AT CAMP LEJEUNE,**
 6 **NORTH CAROLINA.**

7 (a) IN GENERAL.—Subchapter II of chapter 11 of
 8 title 38, United States Code, is amended by adding at the
 9 end the following new section:

10 **“§ 1119. Presumptions of service connection for ill-**
 11 **nesses associated with contaminants in**
 12 **the water supply at Camp Lejeune, North**
 13 **Carolina**

14 “(a) PRESUMPTION.—(1) For purposes of section
 15 1110 of this title, and subject to section 1113 of this title,
 16 each illness, if any, described in paragraph (2) shall be
 17 considered to have been incurred in or aggravated by serv-
 18 ice referred to in that paragraph, notwithstanding that
 19 there is no record of evidence of such illness during the
 20 period of such service.

21 “(2) An illness referred to in paragraph (1) is any
 22 diagnosed or undiagnosed illness that—

23 “(A) the Secretary determines, in consultation
 24 with the Agency for Toxic Substances and Disease

1 Registry, in regulations prescribed under this section
2 to warrant a presumption of service connection by
3 reason of having a positive association with exposure
4 to volatile organic compounds, including known
5 human carcinogens and probable human carcino-
6 gens, known or presumed to be associated with serv-
7 ice in the Armed Forces at Camp Lejeune, North
8 Carolina, during a period determined by the Sec-
9 retary in consultation with the Agency for Toxic
10 Substances and Disease Registry; and

11 “(B) becomes manifest within the period, if
12 any, prescribed in such regulations in a veteran who
13 served on active duty at Camp Lejeune, North Caro-
14 lina, and by reason of such service was exposed to
15 such compounds.

16 “(3) For purposes of this subsection, a veteran who
17 served on active duty at Camp Lejeune, North Carolina,
18 during the period referred to in paragraph (2)(A) and who
19 has an illness described in paragraph (2) shall be pre-
20 sumed to have been exposed by reason of such service to
21 the compound associated with the illness in the regulations
22 prescribed under this section unless there is conclusive evi-
23 dence to establish that the veteran was not exposed to the
24 compound by reason of such service.

1 “(b) DETERMINATIONS RELATING TO DISEASES.—

2 (1) Whenever the Secretary determines, in consultation
3 with the Agency for Toxic Substances and Disease Reg-
4 istry, on the basis of sound medical and scientific evidence,
5 that a positive association exists between the exposure of
6 humans to a volatile organic compound known or pre-
7 sumed to be present in the water supply at Camp Lejeune,
8 North Carolina, and the occurrence of a disease in hu-
9 mans, the Secretary shall prescribe regulations providing
10 that a presumption of service connection is warranted for
11 that disease for the purposes of this section.

12 “(2) In making determinations for the purpose of this
13 subsection, the Secretary shall take into account all other
14 sound medical and scientific information and analyses
15 available to the Secretary. In evaluating any study for the
16 purpose of making such determinations, the Secretary
17 shall take into consideration whether the results are statis-
18 tically significant, are capable of replication, and with-
19 stand peer review.

20 “(3) An association between the occurrence of a dis-
21 ease in humans and exposure to a volatile organic com-
22 pound shall be considered to be positive for the purposes
23 of this section if the credible evidence for the association
24 is equal to or outweighs the credible evidence against the
25 association.

1 “(c) REMOVAL OF DISEASES.—Whenever a disease is
2 removed from regulations prescribed under this section—

3 “(1) a veteran who was awarded compensation
4 for such disease on the basis of the presumption pro-
5 vided in subsection (a) before the effective date of
6 the removal shall continue to be entitled to receive
7 compensation on that basis; and

8 “(2) a survivor of a veteran who was awarded
9 dependency and indemnity compensation for the
10 death of a veteran resulting from such disease on
11 the basis of such presumption shall continue to be
12 entitled to receive dependency and indemnity com-
13 pensation on such basis.”.

14 (b) CLERICAL AMENDMENT.—The table of sections
15 at the beginning of such chapter is amended by inserting
16 after the item relating to section 1118 the following new
17 item:

“1119. Presumptions of service connection for illnesses associated with contami-
nants in the water supply at Camp Lejeune, North Carolina.”.
