A BILL

To extend for 1 year the Emergency Contingency Fund for State Temporary Assistance for Needy Families Programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Emergency Jobs Pro-
5 gram and Assistance for Families Extension Act”.

1 **SEC. 2. 1-YEAR EXTENSION OF THE EMERGENCY CONTIN-**
2 **GENCY FUND FOR STATE TEMPORARY AS-**
3 **SISTANCE FOR NEEDY FAMILIES PROGRAMS.**

4 (a) IN GENERAL.—Section 403(c) of the Social Secu-
5 rity Act (42 U.S.C. 603(c)) is amended—

6 (1) in paragraph (2)(A), by inserting “, and for
7 fiscal year 2011, such sums as are necessary” before
8 “for payment”;

9 (2) in paragraph (2)(B)—

10 (A) by striking “2010” the 1st place it ap-
11 pears and inserting “2011”; and

12 (B) by striking “and 2010” and inserting
13 “through 2011”;

14 (3) in paragraph (2)(C), by striking “2010”
15 and inserting “2011”;

16 (4) in clause (i) of each of subparagraphs (A),
17 (B), and (C) of paragraph (3), by striking “year
18 2009 or 2010” and inserting “years 2009 through
19 2011”;

20 (5) in paragraph (3)(C)(iii), by striking “80”
21 and inserting “100”;

22 (6) by adding at the end of paragraph (3) the
23 following:

24 “(D) GRANT RELATED TO INCREASED EX-
25 PENDITURES FOR WORK SUPPORT SERVICES.—

1 “(i) IN GENERAL.—For each calendar
2 quarter in fiscal year 2010 or 2011, the
3 Secretary shall make a grant from the
4 Emergency Fund to each State that—

5 “(I) requests a grant under this
6 subparagraph for the quarter; and

7 “(II) meets the requirement of
8 clause (ii) for the quarter.

9 “(ii) WORK SUPPORT SERVICES EX-
10 PENDITURE REQUIREMENT.—A State
11 meets the requirement of this clause for a
12 quarter if the total expenditures of the
13 State for work support services in the
14 quarter, whether under the State program
15 funded under this part or as qualified
16 State expenditures, exceeds the total such
17 expenditures of the State in the cor-
18 responding quarter in the emergency fund
19 base year of the State.

20 “(iii) AMOUNT OF GRANT.—Subject to
21 paragraph (5), the amount of the grant to
22 be made to a State under this subpara-
23 graph for a quarter shall be an amount
24 equal to 80 percent of the excess described
25 in clause (ii).”;

1 (7) by adding at the end of paragraph (5) the
2 following: “The total amount payable to a single
3 State under subsection (b) and this subsection for
4 fiscal year 2011 shall not exceed 50 percent of the
5 annual State family assistance grant.”; and

6 (8) in paragraph (9)—

7 (A) by adding at the end of subparagraph

8 (B)(ii) the following:

9 “(IV) The total expenditures of
10 the State for work support services,
11 whether under the State program
12 funded under this part or as qualified
13 State expenditures.”; and

14 (B) by adding at the end the following:

15 “(D) WORK SUPPORT SERVICES.—The
16 term ‘work support services’ means services de-
17 signed to help an individual begin, remain, or
18 advance in employment, as indicated by any
19 guidance that the Secretary may provide.”.

20 (b) CONFORMING AMENDMENTS.—Section 2101 of
21 division B of the American Recovery and Reinvestment
22 Act of 2009 (Public Law 111–5) is amended—

23 (1) in subsection (a)(2)—

24 (A) by striking “2010” and inserting
25 “2011”; and

1 (B) by striking all that follows “repealed”
2 and inserting a period; and
3 (2) in subsection (d)(1), by striking “2010”
4 and inserting “2011”.
