## A BILL

1	SECTION 1. ONE-YEAR MORATORIUM ON SALE OR FORE-
2	CLOSURE OF PROPERTY OWNED BY SUR-
3	VIVING SPOUSES OF SERVICEMEMBERS
4	KILLED IN OPERATION IRAQI FREEDOM OR
5	OPERATION ENDURING FREEDOM.
6	(a) Moratorium.—Section 303 of the
7	Servicemembers Civil Relief Act (50 U.S.C. App. 533) is
8	amended—
9	(1) by redesignating subsection (d) as sub-
10	section (e);
11	(2) by inserting after subsection (c) the fol-
12	lowing new subsection (d):
13	"(d) Death of Servicemember.—
14	"(1) Sale or foreclosure.—In the case of
15	the surviving spouse of a servicemember described in
16	paragraph (2) who has an obligation described in
17	subsection (a), a sale, foreclosure, or seizure of prop-
18	erty for a breach of such an obligation shall not be
19	valid if made during the one-year period beginning
20	on the date of the servicemember's death except—
21	"(A) upon a court order granted before
22	such sale, foreclosure, or seizure with a return
23	made and approved by the court; or
24	"(B) if made pursuant to an agreement as
25	provided in section 107

1 "(2) Eligible servicemembers.—A service-2 member described in this paragraph is a service-3 member who dies while serving on active duty in 4 support of Operation Iraqi Freedom or Operation 5 Enduring Freedom."; and 6 (3) in subsection (a)— 7 (A) in the matter preceding paragraph (1), by inserting after "servicemember" the fol-8 lowing: ", or for purposes of subsection (d), the 9 10 surviving spouse of a servicemember described 11 in paragraph (2) of that subsection,"; and 12 (B) in paragraph (1), by inserting after "servicemember" the following: ", or for pur-13 poses of subsection (d), the surviving spouse of 14 15 a servicemember described in paragraph (2) of 16 that subsection,". 17 (b) Effective Date.—The amendments made by 18 subsection (a), shall apply with respect to deaths occurring on or after the date of the enactment of this Act.
