## A BILL

To extend the emergency unemployment compensation  
program through the end of fiscal year 2010.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Unemployment Insur-  
5 ance Extension Act of 2010”.

6 **SEC. 2. EXTENSION OF EMERGENCY UNEMPLOYMENT COM-**  
7 **PENSATION PROGRAM THROUGH THE END**  
8 **OF FISCAL YEAR 2010.**

9 (a) EMERGENCY UNEMPLOYMENT COMPENSA-  
10 TION.—

1           (1) IN GENERAL.—Section 4007 of the Supple-  
2           mental Appropriations Act, 2008 (Public Law 110–  
3           252; 26 U.S.C. 3304 note) is amended—

4                   (A) by striking “February 28, 2010” each  
5                   place it appears and inserting “September 30,  
6                   2010”;

7                   (B) in the heading for subsection (b)(2),  
8                   by striking “FEBRUARY 28, 2010” and inserting  
9                   “SEPTEMBER 30, 2010”; and

10                  (C) in subsection (b)(3), by striking “July  
11                  31, 2010” and inserting “February 28, 2011”.

12           (2) ADDITIONAL REGULAR COMPENSATION.—  
13           Section 2002(e) of the Assistance for Unemployed  
14           Workers and Struggling Families Act, as contained  
15           in Public Law 111–5 (26 U.S.C. 3304 note; 123  
16           Stat. 438), is amended—

17                   (A) in paragraph (1)(B), by striking “Feb-  
18                   ruary 28, 2010” and inserting “September 30,  
19                   2010”;

20                   (B) in the heading for paragraph (2), by  
21                   striking “FEBRUARY 28, 2010” and inserting  
22                   “SEPTEMBER 30, 2010”; and

23                   (C) in paragraph (3), by striking “August  
24                   31, 2010” and inserting “March 31, 2011”.

1           (3) FULL FUNDING OF EXTENDED BENE-  
2           FITS.—Section 2005 of the Assistance for Unem-  
3           ployed Workers and Struggling Families Act is  
4           amended—

5                   (A) by striking “February 28, 2010” each  
6                   place it appears and inserting “September 30,  
7                   2010”; and

8                   (B) in subsection (c), by striking “July 31,  
9                   2010” and inserting “February 28, 2011”.

10          (4) EXTENSION OF TEMPORARY FEDERAL  
11          MATCHING FOR THE FIRST WEEK OF EXTENDED  
12          BENEFITS FOR STATES WITH NO WAITING WEEK.—  
13          Section 5 of the Unemployment Compensation Ex-  
14          tension Act of 2008 (Public Law 110–449; 26  
15          U.S.C. 3304 note) is amended by striking “July 31,  
16          2010” and inserting “September 30, 2010”.

17          (5) TECHNICAL CORRECTION.—Section  
18          4007(b)(2) of the Supplemental Appropriations Act,  
19          2008 is amended by striking “of section 4002 of sec-  
20          tion 4002” and inserting “of section 4002”.

21          (b) FUNDING FOR TEMPORARY EXTENSION OF CER-  
22          TAIN UNEMPLOYMENT BENEFITS.—Section 4004(e)(1) of  
23          the Supplemental Appropriations Act, 2008 is amended—

24                   (1) in subparagraph (B), by striking “and” at  
25                   the end; and

1           (2) by adding after subparagraph (C) the fol-  
2       lowing:

3                   “(D) the amendments made by section 2 of  
4       the Unemployment Insurance Extension Act of  
5       2010; and”.
